During the 86th Regular Session of the 5th Sangguniang Panlungsod of the City of Bacoor, Cavite, The Committee on Public Works and Highways, Chairman Hon. Levy M. Tela, The proposed city resolution on the ratification of the act of signing of the City Mayor on the Job Order Contracts of the Project-based/Job Order Hirees of the LRT 1 Extension Project. Relative to the preparation, resettlement, and relocation of project-affected families. Considering further that the Job Order personnel have commenced their services on March 12, 2024.

FINDINGS:

- The National Government, through the Department of Transportation (DOTr) and the Light Rail Transit Authority (LRTA), extended the Light Rail Transit Line 1 (LRT-1) from Baclaran, Parañaque to Bacoor City, Cavite.
- The LRT Line 1 South (Cavite) Extension Project shall extend to two (2) stations in the City of Bacoor, such as the Zapote Station and the Niog Station.
- The LRT Line 1, South (Cavite) Extension Project shall affect hundreds of families who are residents of the City of Bacoor.
- The DOTr, the LRTA, the Department of Human Settlements and Urban Development (DSHUD), the National Housing Authority (NHA) and the City of Government of Bacoor entered into a Memorandum of Agreement (MOA) where the national government agencies transferred funds to the City Government to implement the social preparation, structural mapping, resettlement, and relocation of project-affected families in the City of Bacoor.


