Subject: A RESOLUTION AUTHORIZING THE RENOVATION OF THE MULTI-PURPOSE HALL TO A KADIWA STORE AND TO APPROVE THE UTILIZATION OF THE KADIWA FINANCIAL GRANT FOR THE PURCHASE OF A MOTOR VEHICLE FOR THE USE OF THE SAID KADIWA STORE - PCR-559-2024 dated April 15, 2024

Referred to this Committee on the 86th Regular Session is the above-subject matter for appropriate action and recommendation.

It may be recalled that this Committee recommended to the Sangguniang Panlungsod the approval of the following proposed city resolutions:

"A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA, TO SIGN A MEMORANDUM OF AGREEMENT ON BEHALF OF THE CITY GOVERNMENT OF BACOR WITH THE DEPARTMENT OF AGRICULTURE FOR THE IMPLEMENTATION OF THE KADIWA FINANCIAL GRANT ASSISTANCE PROGRAM - PCR-533-2024 dated March 11, 2024"

"A RESOLUTION AMENDING CITY RESOLUTION NO. 2023-377, OR THE RESOLUTION AUTHORIZING THE CITY TREASURER, ATTY. EDITH NAPALAN, TO OPEN A BANK ACCOUNT ON BEHALF OF THE CITY GOVERNMENT OF BACOR WHERE THE FINANCIAL GRANT FOR THE CITY GOVERNMENT'S KADIWA CENTER PROJECT WILL BE DEPOSITED - PCR 537-2024 dated March 11, 2024"

All the requirements for the grant of said financial assistance have already been complied with by the City Government of Bacoor, accordingly the Department of Agriculture (DA) acknowledged said compliance and implemented the transfer of the fund for utilization in the execution of the Kadiwa project.

The Committee finds the request for the utilization of the Kadiwa funds to renovate the multi-purpose hall into a Kadiwa Store, and the purchase of one (1) motor vehicle for the sole use of the Kadiwa Store as proper and reasonable.

RECOMMENDATION:

In view of the foregoing, the Honorable Members of the Committee hereby recommend **TO APPROVE** the City Resolution authorizing the utilization of the Kadiwa fund for the renovation of the multi-purpose hall into a Kadiwa store and the purchase of one (1) motor vehicle for said Kadiwa store, subject to the Terms and Conditions provided in the MOA, existing accounting and auditing rules and regulations.





Honorable Rowena Bautista Mendiola, Presiding Officer called the 86th Regular Session to order.

WHEREAS, the DA launched the KADIWA NI ANI AT KITA Financial Assistance Grant Program in 2019 to establish a link between the farmers and fisherfolks and the consuming public.

WHEREAS, it aims to ensure that the food commodities are made available and accessible quality agri- fishery products and other basic commodities at affordable prices to the urban areas; establish additional market for small farmers' and fishers' produce/catch thereby increasing their income; and ensure the stability of prices and supply of food and other basic commodities in the urban areas.

WHEREAS, in 2020, during the COVID-19 pandemic, the Department of Agriculture (DA) was tasked to ensure food availability to the adoption of measures that would facilitate and minimize the disruption of food supply chain.

WHEREAS, as part of the strategy of the DA is to provide financial assistance or grant to Farmers' Cooperative and Associations (FCAs) and community- based organizations (CBOs) in order to capacitate and involve them in the food distribution system.

WHEREAS, the DA relaunched the KADIWA program through the KADIWA Financial Assistance Grant Program where local government units are included as proponents.

WHEREAS, the City Government of Bacoor initiated as a proponent-grantee of the Program to support and involve local farmers and fisherfolks in the City of Bacoor and other nearby cities and municipalities in Cavite in the food distribution system and to further provide access to lower market price to local consumers.

WHEREAS, once the conditions for the grant are complied, the DA shall provide a financial assistance to the City of Bacoor for the KADIWA program.

WHEREAS, it was likewise intended the constructed Multi- Purpose Hall located at the front of the Bacoor Government Center shall be renovated into a KADIWA Store.

WHEREAS, in order to transport and haul the commodities and produce from the FCAs and CBOs to the KADIWA Store, a vehicle is hereby necessary to be acquired.

WHEREAS, the budget for the purchase of the KADIWA Store vehicle is charged against the KADIWA financial grant to the City Government of Bacoor.
