Subject: A RESOLUTION APPROVING CITY OF BACOOR URBAN DEVELOPMENT AND HOUSING BOARD (CBUDHB) RESOLUTION NO. 1, SERIES OF 2024 ENTITLED: "A RESOLUTION ALLOCATING FUNDS TO THE POST RELOCATION LIVELIHOOD PROGRAM IN THE AMOUNT OF FIVE HUNDRED THOUSAND PESOS (Php500,000.00) AND ENDORSING TO THE SANGGUNIANG PANLUNGSOD THE APPROVAL OF THE AUTHORITY OF THE CITY MAYOR, HON, STRIKE B. Acting on the approval of the City of Bacoor Urban Development and Housing Board (CBUDHB) Resolution No. 1, Series of 2024, dated 06 May 2024, this proposed resolution was referred to the committee by the Sangguniang Panlungsod President Pro-Tempore, Hon. Reynaldo D. Palabrica during the 88th regular session held on 29 April 2024.

The Committee on Housing, Land Utilization, and Urban Development, under the esteemed chairmanship of Hon. Alde Joselito F. Pagulayan reports that:

Pursuant to Section 29 of Republic Act No. 7279, or the Urban Development and Housing Act of 1992, the local government unit (LGU), in coordination with the National Housing Authority (NHA), shall provide relocation and resettlement sites with basic services and facilities and access to employment and livelihood opportunities sufficient to meet the basic needs of the affected families.

FINDINGS:

It is clearly shown that the LGU and NHA are obliged to provide basic services and employment opportunities for families affected by the Urban Development and Housing Act of 1992, with funds allocated to the Post-Relocation Livelihood Program.

During the CBUDHB meeting held on 20 March 2024, the members unanimously approved to allocate funds from the Social Housing Trust Fund to the Post Relocation Livelihood Program in the amount of Five Hundred Thousand Pesos (Php 500,000.00).

Section 7 of the CBUDHB Reso No. 1, Series of 2024, provides that the Board has the following specific functions:

- To formulate policies and operational guidelines pertinent to the implementation of the city's housing program.
- To authorize the city treasurer to disburse funds from the city's special housing trust fund in accordance with the requirements of government accounting and auditing rules and regulations.
- To review and recommend for the approval of the Sangguniang Panlungsod the budgetary requirements of the city's housing program.

RECOMMENDATION:

Upon review, the committee recommends APPROVAL of the CBUDHB Reso No. 1, Series of 2024, due to the post-relocation livelihood program being crucial to the sustainability of the resettled families in their new communities of the amount of Five Hundred Thousand Pesos (Php500,000.00), and the approval to authorize the City Mayor, Hon. Strike B. Revilla and the city treasurer were to disburse funds for the said program from the available funds of the Socialized Housing Trust Fund.

Strike B. Revilla and the city treasurer were to disburse funds for the said program from the available funds of the Socialized Housing Trust Fund. The proposal was seconded unanimously by the committee members, and the chair declared the motion APPROVED.

WHEREAS, Section 2 of City Ordinance No. 2013-025 provides that it is the policy of the City Government of Baccor to vigorously pursue a comprehensive, visible and sustainable untendevelopment and housing program which shall uplift the tiving conditions of the deprived sector of the community, particularly the homeless, undertaken in cooperation with concerned national government, egencies, the private sector, and with direct participation of the program beneficiaties;

WHEREAS, Section 7 of the same provides that the Board has the following specific functions:

- To formulate policies and operational guidelines pertinent to the implementation of the City's housing program;
- To authorize the City Treasurer to disburse funds from the City's special housing trust fund in accordance with the requirements of government accounting and auditing rules and regulations;
- Review and recommend for the approval of the Sangguninang Parlungsod the budgetary requirements of the City's housing program.

WHEREAS, the Sociatized Housing Trust Fund is created for the purpose of ensuring the visibility and sustainability of the implementation of the resultement and housing projects of the City.

WHEREAS, the Socialized Housing Trust Fund may only be disbursed upon the authorization of the City of Sacoor Urban Development and Housing Board;

WHEREAS, Section 29 of Republic Act. No. 7279 or the "Urban Development and Housing Act of 1992" states that the local government unit, in coordination with the National Housing Authority, shall provide relocation and resettlement sites with basic services and facilities and access to employment and tivetihood opportunities sufficient to meet the basic needs of the affected families:

NOW THEREFORE, upon motion of ATTY.
