The committee is acting on the approval of the City of Bacoor Urban Development and Housing Board (CBUDHB) Resolution No. 3, Series of 2024, dated 13 May 2024. This proposed resolution was referred to the committee by the Sangguniang Panlungsod President Pro-Tempore, Hon. Reynaldo D. Palabrica during the 88th Regular Session held on 29 April 2024.

The Committee on Housing, Land Utilization, and Urban Development, under the esteemed chairmanship of the Hon. Alde Joselito F. Pagulayan reports the following:

Relative to this, Section 7 of the Local Government Code of 1991 (R.A. 7160) provides that local government units (LGUs) shall provide for basic services and facilities, particularly programs and projects for economically sustainable housing.

#### FINDINGS:

During the CBUDHB meeting held on 20 March 2024, it was discussed that there is a lot adjacent to the Ciudad Kaunlaran Housing Project suitable for economically sustainable housing.

Pagulayan subsequently proposed that the said matter be referred to the Bacoor Urban Development and Housing Board (CBUDHB) and the Office of the City Legal Services (OCLS) for them to conduct due diligence and complete staff work on various matters related to the proposed acquisition of the subject lot by the city government. The proposal was seconded unanimously by the committee members, and the acting chair declared the motion APPROVED.

WHEREAS, Section 2 of City Ordinance No. 2013-025 provides that it is the policy of the City Government of Baccor to vigorously pursue a comprehensive, viable and sustainable urban development and housing program which shall uplift the living conditions of the deprived sector of the community, perticularly the homeless, undertaken in cooperation with concerned national government agencies, the private sector, and with direct participation of the program beneficiaries;


WHEREAS, Section 7 of the same provides that the Board has the following specific functions:

- To authorize the City Treasurer to diaburse funds from the City's special housing trust fund in accordance with the requirements of government accounting and auditing rules and regulations;
- Upon the authorization of the Sangguniang Panlungsod, to acquire lands to be utilized for the housing projects of the city either through negotiated sale or through expropriation proceedings, land swapping, land banking, land assembly or consolidation, joint venture and such other modes of acquisition as may be lawfully allowed;

WHEREAS, Section 7 of the Local Government Code of 1991 (R.A. 7180) provides that local government units shall provide for basic services and facilities particularly programs and projects for economically sustainable housing;

WHEREAS, there is a lot adjacent to the Ciudad Kauntaran Housing Project located at Barangay Molino II, Baccor City Cavite with a total land area of Seventy One Thousand Thirty Six square meters (71,036 sqm) suitable for economically sustainable housing project subject for acquisition;

WHEREAS, Section 19 of the Local Government Code, authorizes the local government, through the local chief executive, to exercise the power of eminent domain



by taking private property for public use, or purpose or welfare for the benefit of the poor and the landless, upon payment of just compensation, pursuant to the provisions of the Constitution and pertinent laws;

WHEREAS, the Socialized Housing Trust Fund is created for the purpose of ensuring the viability and austainability of the implementation of the resettlement and housing projects, be used for the acquisition of properties and may only be disbursed upon the authorization of the City of Baccor Urban Development and Housing Board subject, however to the requirements of the government accounting and auditing rules and regulations;

NOW THEREFORE, upon motion of ENGR, ARTHUR SAN JOSE, Head, Zoning and Land Development Department, duly seconded by MR. ROLANDO VOCALAN, OIC-City Environment Services Department and approved in a meeting of the Bacoor City Local Housing Board dated 20 March 2024 duly essembled at MSBR Conference Room, Bacoor City Hall, BE IT RESOLVED AS IT IS HEREBY RESOLVED to:

- Endorse to the Sanggunaing Panlungsod the approval of authority of the Honorable Strike B. Revilla. City Mayor and Chairman of the City of Bacoor Urban Development and Housing Board to acquire a lot adjacent to the Citylad Kaunlaran Housing Project located at Barangay Molino II, Bacoor City covered by Transfer Certificate of Title No. T-79371 for economically sustainable housing project.
- Direct the Office of the City Legal Services to initiate expropriation proceedings on the aforementioned land, and:
- To appropriate necessary funds from the Socialized Housing Trust Fund for the purpose of the same
