Subject: **A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA, ON BEHALF OF THE CITY GOVERNMENT OF BACOOR TO SIGN A DEED OF DONATION AND ACCEPTANCE WITH CAVITE STATE UNIVERSITY PERTAINING THE GRANT OF TWO MILLION PESOS (Php 2,000,000.00) TO THE LATTER IN SUPPORT OF ITS ON-THE-JOB (OJT) TRAINING PROGRAM AND OTHER EDUCATIONAL PROGRAMS, ACTIVITIES, OR UNDERTAKING. Acting on the authorization of the City Mayor to sign a Deed of Donation and Acceptance with Cavite State University (the "University") in support of its on-the-job (OJT) training program and other educational programs during the 90<sup>th</sup> Regular Session dated 13 May 2024, the Committee on Education, Science, and Technology, chaired by Hon. Alde Joselito F. Pagulayan reports the following:

The City Government of Bacoor (the "City") and the University executed a Memorandum of Agreement (MOA) on 27 February 2024. This MOA established a Tax Mapping Task Force, consisting of eligible participants from both the City and the University, to fulfill the objectives of Executive Order No. 16-2024, Series of 2024, in compliance with CHED Memorandum Order No. 04, Series of 2017.

The City recognizes the substantial service that the University has committed to the Tax Mapping Project. This project benefits the local government of the City of Bacoor and promotes the general welfare of its citizens.

**FINDINGS:**

The abovementioned MOA with the University is relative to the Tax Mapping Project of the City. Being mindful of the substantial service of the University, which will benefit the local government of the City of Bacoor and promote the general welfare of its citizens, the City has shown clear intent to support the University's OJT program through a Deed of Donation Agreement. The City intends to donate PHP 2,000,000.00 to the University, which will be used for the OJT program and other educational activities. The University is authorized to receive such donations, which are tax exempt and deductible from the City's income tax.

# DEED OF DONATION AND ACCEPTANCE

## KNOW ALL MEN BY THESE PRESENTS:

This Deed of Donation and Acceptance ("**Deed**") is made and executed by and between:

**CITY GOVERNMENT OF BACCOOR**, a local government unit created and existing under the laws of the Republic of the Philippines, with principal office and postal address at Bacoor Government Center, Bacoor Boulevard, Barangay Bayanan, Bacoor City, Cavite, represented herein by its City Mayor, **HON. STRIKE B. REVILLA**, pursuant to his authority conferred and embodied in City Resolution No. \_\_\_\_\_ dated \_\_\_\_\_ (hereinafter referred to as the "**DONOR**").

and

**CAVITE STATE UNIVERSITY**, a government educational institution created and existing by virtue of Republic Act No. 8468 with principal office address at Barangay Bancod, Municipality of Indang, Province of Cavite, represented by its President, **DR. HERNANDO D. ROBLES, CEO VI** (hereinafter referred to as the "**DONEE**").

The **DONOR** and the **DONEE** are collectively referred to as the "**Parties**".

## WITNESSETH:

**WHEREAS**, the Parties hereto executed a Memorandum of Agreement dated 27 February 2024<sup>1</sup> wherein a Tax Mapping Task Force is constituted, consisting of eligible participants from the City Government of Bacoor and the Cavite State University ("**University**"), in order to fulfill the objectives of Executive Order No. 16-2024, Series of 2024, without prejudice to CHED Memorandum Order No. 04, Series of 2017;

**WHEREAS**, the **DONOR** is mindful of the substantial service the **DONEE** has committed to contribute to the above-mentioned Tax Mapping project which will benefit the local government of the City of Bacoor and promote the general welfare of its citizens;

**WHEREAS**, the **DONOR** intends to donate cash money in the amount of Philippine Pesos: Two Million and 00/100 (PhP 2,000,000.00) in favor of the **DONEE**, which amount shall be used in support of the latter's on-the-job training (OJT) program and other educational programs, activities, undertaking of the **University**;

**WHEREAS**, the **DONEE**, pursuant to its charter, may receive donations of properties of all kinds for the benefit of the **University**, and subject to the limitations, directions and instructions of the **DONOR**, if any;<sup>2</sup>

**WHEREAS**, donations to the DONEE are exempt from all taxes and shall be considered as deductible items from the income tax of the DONOR;<sup>3</sup>

**WHEREAS**, the tax exemption on the donation subject of this Deed is not among those rendered withdrawn by the effectivity of R.A. No. 7160, otherwise known as the Local Government Code;<sup>4</sup>

**NOW, THEREFORE**, for and in consideration of the foregoing and the terms and conditions hereinafter set forth, the Parties hereby agree, as they have agreed, as follows:

1. The DONOR hereby voluntarily and freely gives, transfers, and conveys by way of donation unto the DONEE cash money in the amount **PHILIPPINE PESOS: TWO MILLION AND 00/100 (PHP 2,000,000.00)**, with the check therefor to be released by the DONOR within sixty (60) days from execution hereof.
2. The DONOR affirms that this donation is not made with intent to defraud its creditors, and that it the same is within the budget disbursements of the DONOR.
3. The DONEE hereby receives and accepts the foregoing gift and donation made in its favor by the DONOR and hereby expresses its gratitude to the DONOR.
