Subject: *A resolution supporting House Bill No. 9578 entitled "An act declaring the Sineguelasan Mangroves Park, located in Dulong Pulo, Barangay Sinbanali, Bacoor City, Province of Cavite, and Ecotourism Zone to be known as City of Bacoor Mangrove and Ecotourism Park."*

The 92nd Regular Session was held last May 27, 2024 at the Session Hall of the Sangguniang Panglungsod. City Vice Mayor and Presiding Hon. Rowena Bautista Mendiola presided the Regular Session and was called to order at exactly 10:00 a.m.

Atty. Khalid Atega, Jr., Secretary of the Sangguniang Panlungsod proceeded with the roll call, the approval of the Journal and minutes of the 91st Regular Session, and the reading of the referrals to committees of proposed Ordinances, Resolutions, Messages, Communications, Petitions and Memorials.

City Councilor Honorable Reynaldo C. Palabrica moved for the suspension of the internal rules duly seconded by the members of the Sangguniang Panlungsod, the internal rules were suspended.

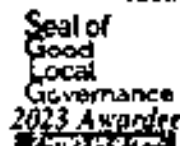

EXPLANATORY NOTE

This bill seeks to declare the Sineguelasan Mangroves Park, located in Dulong Pulo, Barangay Sinbanali, Bacoor City, Province of Cavite, an ecotourism zone to be known as City of Bacoor Mangrove and Ecotourism Park. The bill also seeks to provide for the necessary provisions to ensure the protection and preservation of the park.

The bill defines the Sineguelasan Mangroves Park as a natural area of ecological, scientific, and historical interest, and as a place of scenic beauty and scientific interest. The bill also provides for the necessary provisions to ensure the protection and preservation of the park, including the appointment of a park manager and the establishment of a park fund.

For the purpose of this bill, the following definitions shall apply:

Sineguelasan Mangroves Park - A natural area of ecological, scientific, and historical interest, and as a place of scenic beauty and scientific interest.

DECLARING THE SINEGUELASAN MANGROVES PARK, LOCATED IN DULONG PULO, BARANGAY SINBANALI, BACOOR CITY, PROVINCE OF CAVITE, AN ECOTOURISM ZONE TO BE KNOWN AS CITY OF BACOOR MANGROVE AND ECOTOURISM PARK

Enacted by the Senate and House of Representatives of the Philippines in Congress assembled

SECTION 1. The Sineguelasan Mangroves Park, located in Dulong Pulo, Barangay Sinbanali, City of Bacoor, Province of Cavite, is hereby declared an ecotourism zone to be known as the City of Bacoor Mangrove and Ecotourism Park. Pursuant thereto, its development shall be prioritized and supported by the Department of Tourism (DOT) subject to the rules and regulations governing the development of ecotourism zones.

SECTION 2. Within one (1) year after the approval of this Act, the City Government of Bacoor shall, in coordination with the DOT, Department of Environment and Natural Resources (DENR) through the Provincial Environment and Natural Resources Office (PENRO), the Office of the Second District Representative of Cavite, other concerned agencies of government and community stakeholders, prepare a tourism development plan that shall include the construction, installation, and maintenance of such appropriate infrastructure and facilities to enhance tourism in the area. *Provided*, That said development plan shall ensure the preservation and conservation of the natural beauty and resources of the area. *Provided*, further, That the implementation of the tourism development plan shall be included in the budget of the City Government of Bacoor with the assistance of the

DOT TEZA or Tourism Infrastructure and Enterprise Zone Authority and other agencies of government and the private sector.

SECTION 3. The DOT shall assist the City Government of Bacoor in the implementation of the tourism development plan by providing technical assistance and in tourism capacity building. It shall also include the City of Bacoor Mangrove and Ecotourism Park in its national and regional promotion programs.

SECTION 4. The funding for the implementation of this Act shall be included in the annual budget of the city government of Bacoor. The DOT may augment such allocation with internally-generated funds. The local government may seek partnerships with private sector through joint venture and private-public partnerships in accordance with law and local ordinances.

SECTION 5. Within sixty (60) days from the effectivity of this Act, the City Government of Bacoor shall, in consultation with the DENR through the Cavite-PENRO, the Second District Representative of Cavite, the DOT, other concerned agencies of government, and community stakeholders promulgate rules and regulations to implement this Act.

SECTION 6. If any provision of this Act shall be declared unconstitutional or invalid, the other provisions not affected thereby shall remain in full force and effect.

SECTION 7. All laws, rules, regulations, presidential decrees and other issuances inconsistent with any of the provisions of this Act are hereby deemed repealed or amended accordingly.

SECTION 8. This Act shall take effect fifteen (15) days after its publication in the Official Gazette or in a newspaper of general circulation.
