Pursuant to Section 16 of the Local Government Code of 1991 provides, among others that the local government units shall ensure and support the preservation and enrichment of arts and culture. As the Marching Band Capital of the Philippines, Bacoor City is renowned for its rich cultural legacy and artistic expression that powerfully convey the identity, history and goals while fostering a sense of national pride.

The adoption by the Sangguniang Panlungsod of Provincial Ordinance No. 441-2024 entitled "An Ordinance Institutionalizing the Celebration of National Arts Month every February of each Year in the province of Cavite". The said Provincial Ordinance was enacted in accordance with Proclamation No.683, s. 1991, which designates February as National Arts Month in recognition of the vital role the arts play in enhancing our cultural legacy.

Upon thorough review of the Committee on Youth and Sports Development and Committee on Rules and Privileges, Laws and Ordinances the Provincial Ordinance No. 441-2024 must be adopted by the City Government of Bacoor to promote diverse creative abilities and cultural events, and to encourage young Bacooreño to participate in National Arts Month.



April 15, 2024 Prop'l Ord. No. 441-2024

WHEREAS, pursuant to Proclamation No. 883, s. 1991, the month of February is officially recognized and declared as National Arts Month, acknowledging the crucial role of arts in enriching our cultural heritage;

WHEREAS, the Local Government Code of 1991 particularly Section 16, provides, among others that the local government units shall ensure and support the preservation and enrichment of arts and culture;

WHEREAS, the arts serve as a powerful vehicle for the expression of our identity, heritage, and aspirations, contributing to the unity and pride of the people of Cavite;

WHEREAS, the Province of Cavite is a home of vibrant and diverse cultural community with a rich history and heritage that deserves recognition and celebration;

WHEREAS, there is a need for the Province of Cavite to celebrate the National Arts Month to encourage young Caviteños to participate in various artistic and cultural activities and showcase their talents and unique cultural expressions;

NOW, THEREFORE, on motion of Hon. Same, duly seconded by Hon. Bongro, Hon. Enriquez, Hon. Jaro, Hon. Remulla, Hon. Salazar, Hon. Sison and unanimously approved by the Members present, be it enacted by the Sangguniang Panlalawigan of Cavite in a session duly assembled that:

SECTION 1. SHORT TITLE. This ordinance shall be known and cited as "The National Arts Month Ordinance of the Province of Cavite"

SECTION 2: DECLARATION OF POLICY. The Provincial Government of Cavite has the responsibility to enable Caviteños, especially the youth, to fulfil their vital role in nation-building and to enjoy all Sangguniang Kabataan to undertake activities that promote local culture and arts, such as music, dance or theatre performances. The province supports in celebrating the bounty of artistic endeavors and the passion of Caviteño artists and cultural workers.

SECTION 3: CELEBRATION. The National Arts Month shall be celebrated every February of each year in the Province of Cavite.

SECTION 4: GENERAL OBJECTIVES. The objectives for the celebration of the National Arts Month of the Province of Cavite are to promote artistic talents and showcase the diverse cultural expressions of the Caviteños. This will also promote cultural appreciation and public awareness, undertaking activities through music, dance or theatre performances, film or visual arts exhibits and other events that are likely to foster arts and culture.

SECTION 5: IMPLEMENTING OFFICE: PROGRAM OF ACTIVITIES.
The Office of the Sangguniang Kabataan Provincial Federation, in cooperation with the Office of the Provincial Tourism Officer, shall formulate program and activities for the celebration of the National Arts Month in the province, showcasing the artistic talents of Caviteños, as well as providing avenues for artists to channel their creative energies. Among the events include, but not limited to, art fairs and flagship programs on architecture and allied arts, cinema, dance, dramatic arts, literary arts, music and visual arts.

SECTION 6: SEPARABILITY CLAUSE. If any part or portion of this ordinance is declared unconstitutional, the other remaining parts or portions not affected thereby shall continue to be in full force and effect.

SECTION 7: REPEALING CLAUSE. All ordinances contrary to this ordinance are hereby deemed repealed or modified accordingly.

SECTION 8: EFFECTIVITY CLAUSE. This ordinance shall take effect after its approval.
