A proposal for a resolution directing all Punong Barangay to assist the personnel of the City Assessor's Office in the conduct of tax mapping activities. This initiative aims to enhance the efficiency and accuracy of property assessments, which are crucial for equitable tax collection and resource allocation within the city.

FINDINGS:

The key points in implementing this resolution were:

1. Purpose of Tax Mapping:

-Accurate Property Assessment: Tax mapping ensures that all properties within the city are accurately assessed, leading to fair and equitable property tax assessments.

- Updated Records: It helps maintain updated and accurate records of property ownership, boundaries, and improvements, which are essential for effective local governance.

2. Role of Punong Barangay:

-Local Knowledge: Punong Barangay have in-depth knowledge of their respective barangays, which is invaluable for the accurate identification and verification of properties.

-Community Engagement: Their involvement fosters community cooperation and ensures that residents are informed and engaged in the tax mapping process.

- Support and Coordination: Assisting the City Assessor's Office ensures that tax mapping activities are conducted smoothly and efficiently, minimizing disruptions and delays.


