COMMITTEE ON RULES AND PRIVILEGES, LAWS AND ORDINANCES

CRPLO-PCR-593-2024

Subject: A resolution directing the Office of the City Legal Service to provide free legal assistance to Bacoor City landowners who want to correct errors on their certificates of title pertaining to the location of their respective properties.

(Date referred: June 10, 2024)

The above-mentioned proposed ordinance underwent its first reading on June 10, 2024 during the 94th Regular Session of the Sangguniang Panlungsod. The said proposed ordinance was referred by the Presiding Officer, City Vice Mayor Hon, Rowena Bautista Mendiola to the Committee on Rules and Privileges, Laws and Ordinances.

FINDINGS:

A letter from the Office of the City Mayor dated December 05, 2023 was received by the Sangguniang Panlungsod requesting the City Council to undertake the appropriate legislative action regarding the payment of real property taxes with other local governments by taxpayers who have land within the City of Bacoor.

The Committee on Finance and Budget Appropriations conducted a series of hearings regarding the said request and recommended several legislative actions that the Sangguniang Panlungsod should undertake in order to prevent the situation reported by the City Mayor from repeatedly occurring.

Among the proposed actions submitted by the Committee on Finance and Budget Appropriations is for the creation and approval of a Resolution directing the Office of the City Legal Service to provide free legal assistance to landowners who want to correct errors on their certificates of title pertaining to the location of their respective properties.
