Subject: A resolution expressing the profound sympathy and sincere condolences of the Sangguniang Panlungsod of the City of Bacoor, Cavite on the demise of former Councilor Bayani Mascardo de Leon and honoring the memory of his exemplary and distinguished service to the people of the City of Bacoor, Cavite.

(Date referred: June 10, 2024)

The above-mentioned proposed resolution underwent its first reading on June 10, 2024 during the 94th Regular Session of the Sangguniang Panlungsod. The said proposed ordinance was referred by the Presiding Officer, City Vice Mayor Hon. Rowena Bautista Mendiola to the Committee on Rules and Privileges, Laws and Ordinances.

FINDINGS:

Bayani Mascardo De Leon became a councilor of the former Municipality of Bacoor, Cavite in 2007 and became Chairperson of the Committee on Housing and Land Utilization and the Committee on Peace and Order of the Sangguniang Bayan.

As a member of the Sangguniang Bayan and of the Sangguniang Panlungsod when the City of Bacoor, Cavite was created due to the approval of Republic Act No. 10160 (the "Charter of the City of Bacoor, Cavite") on 23 June 2012, Councilor De Leon authored several landmark pieces of local legislation that Bacoorenos are still benefiting from to this day.

The ebullient personality of Councilor De Leon gave otherwise drab or tension-filled public hearings conducted by the committees he chaired an appropriate level of levity which led to a swifter completion of the tasks that were assigned to him by the Sanggunian.
