We quote Section 22 of the "Local Government Code of 1991" as follows:

"Section 22. Corporate Powers. – (a) Every local government unit, as a corporation, shall have the following powers:

XXX

- (4) To acquire and convey real or personal property:
- (5) To enter into contracts; and

(6) To exercise such other powers as are granted to corporations, subject to the limitation provided in this Code and other laws."



Honorable Reynaldo Palabrica, Presiding Officer/Pro-Tempore called the 98TH Regular Session to order,

Atty. Khalid Atega, Jr., Secretary of the Sangguniang Panlungsod, proceeded with the roll call, the approval of the Journal and Minutes of the 97TH Regular Session, and the reading of the referrals to committees of proposed Ordinances, Resolutions, Messages, Communications, Petitions and Memorials.

On motion by Honorable Alde Pagulayan which was unanimously seconded by the majority of the Honorable Members of Sangguniang Panlungsod, the internal rules were suspended.

Upon reading and referral of Agenda Item No. F.2.3 – PCR-618-2024 – "A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA, ON BEHALF OF THE CITY GOVERNMENT OF BACOOR TO SIGN A DEED OF DONATION AND ACCEPTANCE WITH THE MUNICIPALITY OF KAWIT CAVITE REGARDING THE DONATION OF FIVE (5) UNITS OF MITSUBISHI L300 WITH FB BODY." Honorable Rogelio M. Nolasco moved the approval for the Resolution authorizing the City Mayor, Hon. Strike B. Revilla to sign the Deed of Donation and Acceptance on behalf of City Government of Bacoor to improve the capability to deliver public service for governmental purposes.
