FINDINGS:

A local government unit, as a corporation, is vested with the power to enter into a contract, to acquire and to convey properties, real or personal, subject to certain limitations.

We quote Section 22 of the "Local Government Code of 1991" as follows:

"Section 22. Corporate Powers. – (a) Every local government unit, as a corporation, shall have the following powers:

x x x

(4) To acquire and convey real or personal property;

(5) To enter into contracts; and





(6) To exercise such other powers as are granted to corporations, subject to the limitation provided in this Code and other laws.”

RECOMMENDATION:

In view of the foregoing, the Honorable Members of the Committee hereby recommend **TO APPROVE** the Resolution authorizing the City Mayor, Hon. Strike B. Revilla, on behalf of the City Government of Bacoor to sign a Deed of Donation and Acceptance with the **Municipality of Kawit, Cavite** relative to the donation of five (5) units of motor vehicles in favor of the latter, subject to the existing accounting and auditing rules and regulations.

On motion by Honorable Alde Pagulayan which was unanimously seconded by the majority of the Honorable Members of Sangguniang Panlungsod, the internal rules were suspended.

Upon reading and referral of Agenda Item No. **F.2.3 – PCR-618-2024** – “**A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA, ON BEHALF OF THE CITY GOVERNMENT OF BACOOR TO SIGN A DEED OF DONATION AND ACCEPTANCE WITH THE MUNICIPALITY OF KAWIT CAVITE REGARDING THE DONATION OF FIVE (5) UNITS OF MITSUBISHI L300 WITH FB BODY.**” Honorable Rogelio M.
