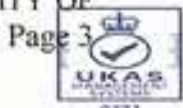

On motion by Honorable Alde Pagulayan which was unanimously seconded by the majority of the Honorable Members of Sangguniang Panlungsod, the internal rules were suspended.

Upon reading and referral of Agenda Item No. **F.2.4 – PCR-619-2024** – “**A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA, ON BEHALF OF THE CITY GOVERNMENT OF BACOOR TO SIGN A DEED OF DONATION AND ACCEPTANCE WITH THE MUNICIPALITY OF ROSARIO CAVITE REGARDING THE DONATION OF FOUR (4) UNITS OF MITSUBISHI L300 WITH FB BODY.**” Honorable Rogelio M. 




The regular session was closed and adjourned at 10:30 A.M.

That each DONEE hereby accepts and receives this donation made in its favor by the DONOR and hereby expresses its appreciation and gratefulness for the kindness and generosity of the DONOR in recognizing the abovementioned goods.
