Subject: A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA, ON BEHALF OF THE CITY GOVERNMENT OF BACOOR TO SIGN A DEED OF DONATION AND ACCEPTANCE WITH VARIOUS BARANGAYS OF THE MUNICIPALITY OF KAWIT, CAVITE REGARDING THE DONATION OF SIXTEEN (16) UNITS OF TOYOTA LITE ACE FX. (PCR-622-2024 dated July 15, 2024)

A proposal regarding the authorization of the City Mayor to sign a Deed of Donation and Acceptance with various barangays in the Municipality of Kawit, Cavite. The donation of 16 Toyota Lite Ace FX units will significantly enhance the barangays' capacity to carry out their administrative and community-based duties.

### FINDINGS:

The vehicles will be instrumental in the efficient transportation of personnel, barangay officials, and necessary goods within the communities. It will also aid in emergency response and improve the overall mobility of barangay officials in the discharge of their duties. The barangays receiving the vehicles have demonstrated their readiness to accept and maintain the donated vehicles. Each barangay has committed to using the vehicles solely for official and governmental purposes, in line with the stipulations of the Deed of Donation. The resolution also fosters stronger cooperation between Bacoor and neighboring municipalities, particularly Kawit, which benefits from Bacoor's resources and support. This gesture of goodwill may also open doors for further collaboration on other programs and initiatives that can contribute to regional growth and development.

#### RECOMMENDATION:

The Committee on Barangay Affairs, having thoroughly reviewed the resolution and its attached documents, strongly recommends the **Approval** of the resolution. The benefits to public service delivery, the promotion of the general welfare, and the strengthening of inter-municipal cooperation are clear and will positively impact the barangays of Kawit, Cavite.


