

Subject: A RESOLUTION AMENDING CITY RESOLUTION NO. 2023-370 ENTITLED "A RESOLUTION AUTHORIZING THE CITY MAYOR, STRIKE B. REVILLA, TO SIGN THE DEED OF DONATION WITH THE GOVERNMENT SERVICE INSURANCE SYSTEM RELATING TO THE DONATION OF VARIOUS ROADS, ALLEYS, AND OPEN SPACES IN QUEENS ROW SUBDIVISION AND GARDENIA VALLEY SUBDIVISION IN MOLINO, BACOOR CITY, CAVITE. (PCR 638-2024 dated 29 July 2024)

Acting on the proposed resolution amending City Resolution No. 2023-370, dated 05 August 2024, the aforementioned subject title was referred to the committee by the Sangguniang Panlungsod Presiding Officer, Hon. Rowena Bautista-Mendiola, during the 101st regular session held on 29 July 2024.

Queens Row Subdivision and Gardenia Valley Subdivision in Molino, Bacoor City, Cavite, are areas that have seen significant growth and development, necessitating the expansion and enhancement of their existing infrastructure for the betterment of their community.

Under Section 1 of Presidential Decree No. 1216, an "open space" is defined as an area reserved exclusively for parks, playgrounds, recreational uses, schools, roads, places of worship, hospitals, health centers, barangay centers, and other similar facilities and amenities.

The acceptance of this generous donation from the General Service Insurance System (GSIS) will provide the City of Bacoor with valuable assets that will significantly contribute to the city's infrastructural development and overall urban planning, particularly with respect to the development of open spaces for their intended purposes under P.D. No. 1216.

FINDINGS:

In the email of Mr. Apollo M. Escarez, Vice President Real Estate Asset Disposition and Management Office of the GSIS, to City Mayor Strike B. Revilla dated 22 July 2024, the following information was provided regarding the Deed of Donation and Acceptance (DODA) between the Local Government of Bacoor, Cavite, and GSIS.

The said DODA was reviewed by the GSIS Legal Services Group on 01 April 2024 and by the Office of Government Corporate Counsel (OGCC) on 06 June 2024.

On 13 March 2024, the City of Bacoor provided a copy of Resolution No. 2023-370 from the Sangguniang Panlungsod, dated 13 November 2023. This resolution pertains to the request for a donation, outlines the conditions of the donation, and authorizes a representative. However, in order to maintain consistency with the documents supporting the recommendation to the GSIS Board of Trustees regarding the donation of 29 road lots, 4 open spaces, and 5 alleys, an updated City Resolution is required. The updated resolution must reflect the conditions based on the Deed as reviewed by the OGCC. Hereunder are the amended conditions:

- a. The abovementioned properties subject of donation shall be used exclusively for public use for which it is intended and not for any other purposes.
- Real properties subject of this donation shall not be sold, leased, alienated, converted to any other purpose or purposes, encumbered, or mortgaged pursuant to the provisions of P.D. No. 1216.
- c. Any and all taxes, charges, fees, and/or expenses for the transfer of ownership and registration of the Deed shall be for the account of and be paid by the **Donee**.

- f. The **Donee** shall cause the annotation of the restrictions on the said titles and shall bear the expenses that shall be incurred therein.
- g. The Donee shall provide to the Donor certified true copies of the TCTs registered under the name containing annotated restrictions.
- h. The **Donee** shall be liable directly and/or indirectly for all claims from any persons or entities against the **Donor** concerning the donated properties.
- In the event that any of the provisions of the Deed of Donation will be declared invalid, illegal, or unenforceable, the validity and enforceability of the other provisions in the Deed of Donation shall not, in any manner, be affected.
- j. Authority to the Local Chief Executive of the City Government of Bacoor to sign, execute, and receive the original copy of the Deed of Donation and Acceptance and Transfer Certificates of Title of the said twenty-nine (29) road lots, four (4) open spaces, and five (5) alleys.

RECOMMENDATION:

Upon thorough review of the amended conditions as abovementioned, the committee recommends the APPROVAL of the proposed amendments to City Resolution No. 2023-370, titled "A RESOLUTION AUTHORIZING THE CITY MAYOR, STRIKE B. REVILLA, TO SIGN THE DEED OF DONATION WITH THE GOVERNMENT SERVICE INSURANCE SYSTEM RELATING TO THE DONATION OF VARIOUS ROADS, ALLEYS, AND OPEN SPACES IN QUEENS ROW SUBDIVISION AND GARDENIA VALLEY SUBDIVISION IN MOLINO, BACOOR CITY, CAVITE." 



C) That they shall not be sold, alienated leased, converted nor encumbered or mortgaged:

- D) That the expenses for the transfer of ownership and registration of the Deed of Donation including the management, maintenance, and administration of the donated properties shall be the sale responsibility of the City Government of Baccor;
- E) The City Government of Bacdar hereby accepts without qualification whatsoever the donation under the aforesaid conditions and shall be liable directly and/or indirectly to all claims from any person or entities against the GSIS concerning the properties to be donated;

F) The restrictions contained shall be annotated on the titles to be issued in layor of the City Government of Baccon.

- G) The City Government of Bacoar shall hald the GSIS, its officers, directors, employees, agents, free and hamiless from and against any losses, claims, damages, liabilities expenses and/or costs of litigation resulting from ar arising out of its use of the donated properties:
- H) The City Government of Bacoor shall pay the attorney's fees and all perfinent costs and expenses of litigation if ever the GSIS is constrained to obtain relief before the courts due to any claims, losses, damages, liabilities, expenses, and/or costs of litigation resulting from or orising out of its use of the donated properties;

1) The parties may, upon mutual agreement, amend modify, supplement or otherwise revise in writing any provisions of the Deed of Danation; and


J) In the event that any of the provisions of the Deed of Donation will be declared invalid, illegal or unenforceable the validity and enforceability of the other provisions of the Deed of Donation shall not, in any manner, be affected.

WHEREAS, the acquisition of these infrastructural assets through donation is a cost-effective way for the City Government of Bacoar to enhance its public facilities without incurring significant financial expenditure.
