The above-mentioned subject was referred to the Committee on Games and Amusement chaired by Councilor Michael E. Solis, during the 103rd Regular Session of the 5th Sangguniang Panlungsod of the City of Bacoor, Cavite held on August 13, 2024 at the Sangguniang Panlungsod Session Hall, Bacoor City, Cavite.

The My Maytron Amusement Inc. is willing to continue its E-Bingo operation in the City of Bacoor through a letter of intent dated August 5, 2024 which was received by the Sangguniang Panlungsod secretariat. It was ordered to stop operation upon revocation of all existing documents issued by E-Bingo in Bacoor City. It will only be allowed to continue its operation once it followed the guidelines and meet the requirements/regulations set by the City and pending PAGCOR'S approval on their application.

RECOMMENDATION:

In view of the reasons stated, the committee **RECOMMENDS** that the above-mentioned subject matter be **TEMPORARILY ARCHIVED** and removed from the council's next order of business, pending the compliance/submission of the required documents.


Dear Vice Mayor Mediola ,

A RESOLUTION INTERPOSING NO OBJECTION TO MAI MYTRON AMUSEMENT INC. REPRESENTED BY ITS PRESIDENT MR. MANUEL A. BERGADO TO OPERATE ALL PAGCOR APPROVED GAMES INCLUDING ELECTRONIC BINGO AND ELECTRONIC GAMES AT THE MAINSQUARE MALL, BAYANAN, CITY OF BACOR, CAVITE.

Sponsored by: Coun. Apolonio I. Advincula, Jr., Coun. Leandro D. Leon, Coun. Edwin G. Gawaran, Coun. Victorio L. Guerrero, Jr., Coun. Hernando C. Gutierrez, Coun. Roberto R. Javier, Coun. Gaudencio P. Nolasco, and Coun. Reynaldo D. Palabrica.

WHEREAS Section 447, (3) of Republic Act No. 7160 (otherwise known as the "Local Government Code of 1991") grants the Sangguniang Panlungsod the power, among others, to grant franchises, enact ordinances levying taxes, fees and charges upon such conditions and for such purposes intended to promote the general welfare of the inhabitants of the municipality and to regulate any business, occupation, or practice of profession or calling which does not require government examination, within the municipality and the conditions under which the license for said business or practice of profession may be issued or revoked;

WHEREAS, MAI MYTRON AMUSEMENT INC. with offices located at 229 National Road, Bayanan, Muntinlupa City is a domestic corporation duly organized and existing under and by virtue of Philippine laws;

WHEREAS, the Corporation intends to operate an electronic bingo and other E-games approved by the Philippine Amusement Gaming Corporation (PAGCOR) at Mainsquare Mall, Bayanan, City of Bacoor, Cavite;

WHEREAS, after a thorough deliberation of the said matter, the majority of the members of the Sangguniang Panlungsod of Bacoor City, Cavite during its regular session decided not to pose any objection to the granting of a business permit by the City Mayor to the Corporation to allow the latter to operate all varieties of bingo games including electronic bingo approved by the PAGCOR at the Mainsquare Mall, Bayanan, City of Bacoor, Cavite subject, however, to the strict compliance of the said Corporation to certain conditions hereinafter set forth;

NOW, THEREFORE, upon motion of Councilor Roberto R. Javier, seconded by Councilor Edwin G. Gawaran present in regular session assembled, **BE IT RESOLVED, AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod not to pose any objection to the granting of a business permit by the City

Mayer to the Corporation for the latter's operation of all variations of bingo games including electronic bingo approved by the PAGCOR at the Mainquare Mall Bayanan City of Bacoor Cavite provided that the said Corporation will strictly comply with the following conditions to wit:

- a) the Corporation shall not allow any minor or any student in uniform irrespective of age from entering, loitering, or playing bingo or other games of chance within the premises of the E-halls that it intends to operate at the Mainquare Mall Bayanan City of Bacoor Cavite;
- b) the said business permit shall be limited at the Mainquare Mall Bayanan City of Bacoor Cavite;
- c) the Corporation must first obtain a Fire Inspection Safety Clearance from the Office of the Fire Marshal of Bacoor Cavite before the said business permit can be issued;
- d) the Corporation must submit its Certificate of Incorporation, Articles of Incorporation and By-laws as duly issued and/or approved by the Securities and Exchange Commission (SEC) with the Business Permit and Licensing Office (BPLLO) of the city government before a business permit can be issued to the Corporation;
- e) the Corporation must submit to the BPLLO and to the Office of the Secretary of the Sangguniang Panlungsod a certified true copy of its PAGCOR franchise;
- f) the Corporation must pay any and all pending liabilities and taxes which may include penalties or fines imposed against the Corporation by past municipal administrations that it still owe the city government before such business permit may be issued; and
- g) the Corporation shall be required to pay the City government a city business tax equivalent to one percent (1%) of its gross revenues to the City Treasurer.

RESOLVED, LASTLY, that the Sangguniang Panlungsod reserves the right to repeal this Resolution and seek the revocation of any business permit granted to the Corporation should the latter be found to have violated any of the foregoing conditions or any prevailing laws, ordinances and government regulations.
