A RESOLUTION INTERPOSING NO OBJECTION TO SCRATCH ZONE, INC. TO OPERATE ALL VARIATIONS OF BINGO GAMES INCLUDING ELECTRONIC BINGO IN THE CITY OF BACOR.

Sponsored by: *Hon. Bayani M. De Leon, Hon. Leandro A. De Leon, Hon. Edwin G. Gawaran, Hon. Hernando C. Gutierrez, Hon. Roberto R. Javier, Hon. Gaudencio P. Nolasco, Hon. Reynaldo D. Palabrica, and Hon. Avelino B. Solis.*

WHEREAS, Section 447, (3) of Republic Act, No. 7160 (otherwise known as the "Local Government Code of 1991") grants the Sangguniang Panlungsod the power, among others, to grant franchises, enact ordinances levying taxes, fees and charges upon such conditions and for such purposes intended to promote the general welfare of the inhabitants of the municipality and to regulate any business, occupation, or practice of profession or calling which does not require government examination within the municipality and the conditions under which the license for said business or practice of profession may be issued or revoked.

WHEREAS, SCRATCH ZONE INC. is a domestic corporation duly organized and existing under and by virtue of Philippine laws.

WHEREAS, the Corporation intends to operate an electronic bingo and other bingo games approved by the Philippine Amusement Gaming Corporation (PAGCOR) within the City of Bacoor, Cavite.

WHEREAS, after a thorough deliberation of the said matter, the majority of the members of the Sangguniang Panlungsod of Bacoor City, Cavite during its regular session decided not to pose any objection to the granting of a business permit by the City Mayor to the Corporation to allow the latter to operate all variations of bingo games including electronic bingo approved by the PAGCOR within the City of Bacoor, Cavite subject, however, to the strict compliance of the said Corporation to certain conditions hereinafter set forth.

NOW, THEREFORE, upon motion of Councilor Reynaldo D. Palabrica, unanimously seconded by all the councilors present in regular session assembled, **BE IT RESOLVED, AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod not to pose any objection to the granting of a business permit by the City Mayor to the Corporation for the latter's operation of all variations of bingo games including electronic bingo approved by the PAGCOR within the City of Bacoor, Cavite provided that the said Corporation will strictly comply with the following conditions, to wit:

- a) the Corporation shall not allow any minor, or any student in uniform irrespective of age, from entering, loitering, or playing bingo or other games of chance within the premises of the bingo hall/s that it intends to operate within the City of Bacoor, Cavite;
- b) the said business permit shall be limited within the City Bacoor, Cavite;
- c) the Corporation must first obtain a Fire Inspection Safety Clearance from the Office of the Fire Marshall of Bacoor, Cavite before the said business permit can be issued;
- d) the Corporation must submit its Certificate of Incorporation, Articles of Incorporation and By-laws as duly issued and/or approved by the securities and Exchange Commission (SEC) with the Business Permit and Licensing Office (BPLO) of the city government before a business permit can be issued to the Corporation;
- e) the Corporation must submit to the BPLO and to the Office of the Secretary of the Sangguniang Panlungsod a certified true copy of its PAGCOR franchise.
- f) the Corporation must pay any and all pending liabilities and taxes, which may include penalties or fines imposed against the Corporation by past municipal administrations, that it still owe the city government before such business permit may be issued; and
- g) the Corporation shall be required to pay the city government a city business tax equivalent to one percent (1%) of its gross revenues to the City Treasurer.

RESOLVED, LASTLY, that the Sangguniang Panlungsod reserves the right to repeal this Resolution and seek the revocation of any business permit granted to the Corporation should the latter be found to have violated any of the foregoing conditions or any prevailing laws, ordinances, and government regulations.

ADOPTED this 14th day of September 2015 by the Sangguniang Panlungsod of Bacoor, Cavite during its regular session.


