Referred to the Joint Committee during the 104th Regular Session is the above-subject matter for appropriate action and recommendation.

The approval of the legislative measure for the extension of deadline within which to pay the taxes, fees and charges imposed by the Local Government Units is authorized under Section 167, Chapter 3 of Republic Act No. 7160 otherwise known as the "Local Government Code of 1991". We quote the specific provision, as follow

"TITLE I
BASIC PRINCIPLES

CHAPTER III
Collection of Taxes

X X X

Section 167. Time of Payment. – x x x The sanggunian concerned may, for a justifiable reason or cause, extend the time for payment of such taxes, fees, or charges without surcharges or penalties, but only for a period not exceeding six (6) months."

RECOMMENDATION:

Considering that the requested extension had already been implemented due to its urgency, the Honorable Members of the Joint Committee hereby recommend **TO ARCHIVE** the CDRRMC Resolution No. 06-2024 and the proposed resolution for the extension of deadline in the Business Tax payment.
