**Subject: A resolution adopting the Philippine Population and Development Plan of Action (PDP-POA) for calendar year 2023-2028 and expressing support and cooperation towards its successful implementation.**

The above-mentioned proposed resolution underwent its first reading on October 14, 2024 during the 112<sup>th</sup> Regular Session of the Sangguniang Panlungsod. The said proposed resolution was referred by the Presiding Officer, City Vice Mayor Hon. Rowena Bautista Mendiola to the Committee on Health and Sanitation.

#### FINDINGS:

A letter from the Office of the City Mayor dated October 10, 2024 was received by the Sangguniang Panlungsod, requesting the latter to pass a City Resolution formally adopting the Philippine and Development Plan of Action (PDP-POA) 2023-2028 which will serve as the national government's comprehensive framework for addressing demographic challenges and population-related development issues and as the City's guiding framework for population and development policies, in alignment with the nation's AmBisyon Natin 2040 vision of ensuring a deeply rooted, comfortable, and secure life for all Filipinos.

This plan, spearheaded by the Commission on Population and Development (CPD) in collaboration with national government agencies, civil society organizations, and development partners, outlines strategic actions to empower Filipino families and communities. It seeks to enhance their capacities to improve their quality of life through coordinated support from both public and private sectors.

MEMORANDUM CIRCULAR NO. 14

**APPROVING AND ADOPTING THE PHILIPPINE POPULATION AND DEVELOPMENT PLAN OF ACTION 2023-2028, AND DIRECTING THE IMPLEMENTATION THEREOF**

**WHEREAS** Section 4 of Presidential Decree (PD) No. 705, s. 1976 established the Commission on Population (POPCOM) to formulate, coordinate, monitor, digitalize and disseminate long-term plans, programs and policies consistent to population and human resources and social development objectives approved by the President;

**WHEREAS** Executive Order No. 113, 2016, renamed the POPCOM as the Commission on Population and Development (CPD);

**WHEREAS** the Philippine Development Plan (PDPA) 2023-2028, outside the role of the country's demographic and human resources, has capacity to bring back the country to a high-growth trajectory and create economic and social transformation for a prosperous, inclusive and resilient society;

**WHEREAS** the CPD noted that the Philippine Population and Development Plan of Action (PPD-POA) 2023-2028 is seen as the overall framework for inter-agency collaboration to address demographic opportunities and challenges, and population challenges in order to maximize the attainment of the demographic and socioeconomic development agenda under the PDPA 2023-2028; and

**WHEREAS** it is imperative for a concerted national government efforts and inter-agencies and local government units to work in support and cooperation towards the successful implementation of the PPD-POA 2023-2028;

**NOW, THEREFORE**, in conformity with the foregoing:

Pursuant to Section 1 of PD No. 717, the PPD-POA 2023-2028 is hereby **APPROVED** and **ADOPTED**.

In accordance with their respective mandates, all concerned agencies and instrumentalities of the National Government, including government-owned or controlled corporations, are hereby directed and enjoined to fully cooperate, to undertake efforts in support of the implementation of the PPD-POA 2023-2028, and the plans and programs specified therein.

As the said agency in-charge of formulating and advising comprehensive long-term plans and programs on population, the CPD is hereby directed to:

1. Coordinate, collaborate and establish institutional partnership with concerned government agencies and other stakeholders to ensure the attainment of the goals and objectives set forth in the FPD-PCA through a multi-agency approach;
2. Monitor and assess the implementation of the FPD-PCA at all levels and submit annual reports to the Office of the President, through the Office of the Executive Secretary, on the progress and emerging concerns in the implementation thereof;
3. Undertake comprehensive research and development, monitor, evaluate or analyze population problems, and create partnerships at the national, regional and local levels to optimize work across the impact of population dynamics in four national and local development sectors or strategies, subject to existing laws, rules and regulations; and
4. Study public and municipal concerns on the impact of population dynamics on socioeconomic development.

The Order shall take effect immediately upon publication in the Official Gazette.
