Subject: REQUEST FROM THE CITY ADMINISTRATOR'S OFFICE - A resolution approving the official logo of Malasakit sa Bawat Residente Program and Bacoor Occupational Safety and Health Committee. (PCR-694-2024 date referred October 14, 2024)

The above-mentioned proposed ordinance underwent its first reading on October 14 2024 during the 112th Regular Session of the Sangguniang Panlungsod. The said proposed ordinance was referred by the Presiding Officer, City Vice Mayor Hon. Rowena Bautista Mendiola to the Committee on Rules and Privileges. Laws and Ordinances.

FINDINGS:

The Malasakit Sa Bawat Residente Program was created through E.O. 13-2023: An Order Mandating the Bacoor Disaster Risk and Reduction Management Office. Bacoor Philippine National Police and Bacoor Traffic Management Department to Implement the "Malasakit Sa Bawat Residente (MSBR) Program- a Conduct of 24-Hour Patrolling and Inspection of all roads and Vehicles in the City of Bacoor to Prevent the Rise of Vehicular Accidents" and Bacoor Occupational Safety and Health Committee created through E.O. 53-2023 |: An Order Creating the Bacoor Task Force on Occupational Safety and Health Standards (TF-OSHS) to Protect the Welfare of all Workers in the City of Bacoor. These logos will be used on all official correspondences relative to the said programs.

The Sangguniang Panlungsod received and reviewed the suggested logo design. The members of the committee came to the conclusion following the aforementioned review that the proposed logo designs effectively captured the goals of the launching of the Malasakit Sa Bawat Residente Program, established




