

Subject: A resolution authorizing the City Mayor, Hon. Strike B. Revilla, to sign the absolute sale with Green and Clean Eco System and Management Corporation on behalf of the City Government of Bacoor, Cavite.

(PCR 697-2024: Date referred: October 21, 2024)

The above-mentioned proposed resolution underwent its first reading on October 21, 2024 during the 113th Regular Session of the Sangguniana Panlungsod. The said proposed resolution was referred by the Presiding Officer. City Vice Mayor Hon. Rowena Bautista Mendiola to the Committee on Rules and Privileges, Laws and Ordinances,

The Committee on Rules, Privileges, Laws and Ordinance sent out invitations to resource persons and conducted a committee hearing on November 07, 2024, 1:30 p.m. at the Session Hall of the Sangguniang Panlungsod.

#### FINDINGS:

A letter from the Office of the City Mayor, requesting Hon, Strike B, Revilla for authority to enter into and sign the deed of absolute sale with Green and Clean Eco System and Management Corporation, dated October 15, 2024 was received by the Sangguniang Panlungsod.

The City of Bacoor Urban Development and Housing Board (BUDHB) recognizes the need for additional housing solutions for the displaced families in the community. In relation to this, the Department of Human Settlement and Urban Development (DHSUD) offers temporary shelters for displaced individuals and families in form of "Transitory Shelters".

ATTY. SALVE VALENCIANO "Good afternoon po, I am hoping that the representative from the housing department is here, our office actually hindi po kami yung nagreview ng document, though so far po based on the review wala naman po itong problema. Siguro on the format lang, we recommend that the specific technical description of the property being sold and purchased ay maindicate po natin doon. We also recommend to include the provision on the possession of the transfer of the documents like for example kelan po magtetake effect yung transfer ng original copy of the CTC, tax declaration and yung copy ng mga tax receipts to provide that they have the updated payment of the property taxes."



## DEED OF ABSOLUTE SALE

## KNOW ALL MEN BY THESE PRESENTS:

This Deed of Conditional Sale ("Deed") is made and entered into by and among:

GREEN AND CLEAN ECO SYSTEM AND MANAGEMENT CORPORATION, a domestic corporation under the laws of the Republic of the Philippines, with principal office address at the interior represented by its authorized representative. DR. MARIA CRISTINA ANGELA CARRERA LUSANTA (hereinafter referred to as the "SELLER")

and

The CITY GOVERNMENT OF BACOOR, a local government unit created by Republic Act No. 10160 and existing under the laws of the Republic of the Philippines with its principal address at BACOOR Government Center, Molino Boulevard, Barangay Bayanan, City of Bacoor, Province of Cavite, herein represented by its Local Chief Executive, STRIKE B. REVILLA, pursuant to its authority conferred and embodied in City Resolution No. approved on \_\_\_\_\_\_, by the City Council of Bacoor (hereinafter referred to as the "PURCHASER")

For the purpose of this Deed, each shall be referred to as a "Party" and collectively as the "Parties".

## WITNESSETH:

WHEREAS, SELLER is the true and absolute owner of a parcel of land located at Barangay Niog, Bacoor City, Cavite, with an area of One Thousand Two Hundred Seventy-Nine (1,279) square meters, more or less, covered by and more particularly described in Transfer Certificate of Title (TCT) No. 057-2015011424 ("Subject Property"):<sup>1</sup>

WHEREAS, the PURCHASER has offered to purchase Subject Property from the SELLER, and the SELLER is willing to sell to the PURCHASER the Subject Property, together with all the improvements already existing thereon, subject to certain terms and conditions hereinafter set forth;

NOW, THEREFORE, for and in consideration of the foregoing premises, the payment of the purchase price and all other amounts herein below specified, the SELLER hereby sells, transfers and conveys to the PURCHASER the Subject Property, subject to the following terms and conditions:

- Purchase Price. The PURCHASER undertakes and agrees to pay the SELLER or their successors-in-interest or assigns the purchase price of <u>PHILIPPINE PESOS</u>: <u>EIGHT MILLION (PHP 8,000,000,000)</u> for the entire Subject Property.
- Taxes, Registration Costs and Expenses. The following taxes, costs and expenses shall be for the account of the PURCHASER:

Certified true copy of TCT No. 057-2015020239 is attached herein as Annex "A"

- a. documentary stamp tax, transfer tax, registration fees and other expenses, costs and taxes (other than taxes on the net income of the SELLER or any other tax creditable thereto) imposed or to be imposed in connection with the purchase and sale of the Subject Property and/or transfer of the title thereof from the SELLER to the PURCHASER, the execution and registration of this Deed, the issuance of the certificate of title covering the Subject Property in the name of the PURCHASER and the issuance of the corresponding tax declarations covering the Subject Property in the name of the PURCHASER;
- real property taxes and assessments which shall be imposed on the Subject Property commencing on the possession and/or occupancy by the PURCHASER thereof; and
- c. other fees, charges, expenses and penalties (if any).

Any increase in the foregoing taxes, costs and expenses due to an adjustment in the applicable rates imposed by the relevant government agencies or private entities which shall be in effect at the time such taxes, costs and expenses shall be due or payable shall be for the account of the PURCHASER.

## 3. Miscellaneous Provisions.

- a. This Deed is the complete and exclusive statement of the Deed between the Parties and supersedes all proposals or prior agreements, oral or written, and all other communications between the Parties relating to the subject matter of this Deed. The index and headings of the sections contained herein are used for convenience and ease of reference only and in no way define, limit, or describe the scope or intent of this Deed or any of its provisions.
- b. Both Parties acknowledge and agree that they have fully read and understood the contents of this Deed and that the same shall be considered to have been jointly drafted.
- c. This Deed may not be modified, amended, added to, or otherwise varied except by a document in writing signed by each of the Parties.
- d. In case one or more of the provisions contained in this Deed shall be declared invalid, illegal, or unenforceable in any respect, the validity, legality, and enforceability of the remaining provisions contained herein shall not in any way be affected or impaired thereby.
- This Deed shall be governed by and construed in accordance with the laws of the Philippines.
- f. In the event of litigation arising from, or in connection with, this Deed, the venue of the action shall be in the proper courts of Bacoor City, to the exclusion of all other courts elsewhere situated.
- g. Each Party may execute this Deed in counterparts, each of which shall be deemed an original, but all of which shall constitute as one and the same instrument with the same effect as if the Parties signed the same document.
