

Subject: A resolution authorizing Hon. Palm Angel Buncio (SK Federation President) and/or Hon. Christine G. Genotiva (SK Federation Treasurer) to represent the Sangguniang Kabataan Federation of the City of Bacoor, Cavite in transacting with the Bureau of Internal Revenue and other national government agencies in relation to the federation's application for registration and to secure a tax identification number. (PCR-703-2024: Date referred – October 21, 2024)

The above-mentioned proposed ordinance underwent its first reading on October 21, 2024 during the 113th Regular Session of the Sangguniang Panlungsod. The said proposed ordinance was referred by the Presiding Officer, City Vice Mayor Hon. Rowena Bautista Mendiola to the Committee on Rules and Privileges, Laws and Ordinances.

### FINDINGS:

The Sangguniang Kabataan Federation is mandated to obtain a Tax Identification Number (TIN) from the Bureau of Internal Revenue in order to operationalize the financial independence of the federation pursuant to Republic Act No. 107421 as amended by Republic Act No. 11768.

A Resolution sponsored by Hon. Niña Mae L. Cañete and Hon. Febie Jane E. Tupa was approved by the SK Federation authorizing Hon. Palm Angel Buncio (SK Federation President) and Hon. Christine G. Genotiva (SK Federation Treasurer) to apply registration and to secure Tax Identification Number (TIN) on behalf of the federation.

This resolution was approved to expedite the registration of the SK Federation and obtain a TIN from the Bureau of Internal Revenue.

WHEREAS, pursuant to Section 236 of the National Internal Revenue Code as amended, all texpayers —whether individuals or corporations, who are subject to any internal revenue tax, to register with the Bureau of Internal Revenue and secure a tax identification number (TIN).

WHEREAS, the Sangguniang Kabataan Federation is maindated by Memorandum Circular No. 2023-171. (MANDATORY REGUIREMENTS TO OPERATIONALIZE THE FINANCIAL INDEPENDENCE OF SK. PURSUANT TO SECTION 20 OF REPUBLIC VITZACT (RA) NO. 107421. AS AMENDED BY RA NO. 11768) to obtain a FIN from the BIR in order to operatinalize the financial independence of the Federation pursuant to Republic Act No. 107421 as whended by Republic Act No. 11768.

WHEREAS, the said law authorized the SK Federation to raise funds and to collect dues from its members which would make the Federation subject of internal revenue taxes and will necessible its application for registration with the BIR.

WHEREAS, in order to expedite the registration of the SK Federation and obtain a TIN from the BIR, the Federation unanimously decided to authorize its President, Morr Paim Angel S Burlolo and its Treasurer Mon Christine G Genotive to transact with the BIR and other national government agencies for the said purpose.

NOW THEREFORE, upon motion of Hon. Nina Mae L. Canete, duty seconded by Hon. Febre Jone E. Tupa, BE IT RESOLVED AS IT IS HEREBY RESOLVED by the Sangguniang Kabataan Federation of the City of Bacoor, Cavite during its regular session duty assembled to authorize its President, Hon. Palm Angel B. Buricio, and/or its Treasurer, Hon. Christine G. Genotiva to transact with the BIR and other national government agencies in order to cause the registration of the Federation and obtain a TIN from the BIR.






