Subject: **FROM BARANGAY REAL; RESOLUTION NO. 001 SERIES OF 2024: RESOLUTION RELINQUISHING, ABDICATING, AND CEDING THE ENTIRE CIRMONT AVENUE OF BARANGAY REAL, CITY OF BACOR, CAVITE TO THE CONTROL, SUPERVISION AND AUTHORITY, OF BARANGAY PANAPAAN V, CITY OF BACOR, CAVITE AND TO REQUEST THE SANGGUNIANG PANLUNGSOD TO ENACT A RESOLUTION TO THIS EFFECT. (PNOA 287-2024 dated 12 February 2024)**

This report resolves the request of Barangay Real to relinquish, abdicate, and cede the entire Cirmont Avenue to the control, supervision, and authority of Barangay Panapaan V, City of Bacoor, Cavite, on 05 March 2024. The said resolution was referred to the committee during the 78th Regular Session dated 12 February 2024 by the Sangguniang Panlungsod Presiding Officer, Hon. Rowena Bautista-Mendiola.

The Committee on Housing, Land Utilization and Urban Development, chaired by Hon. Alde Joselito F. Pagulayan hereby reports that:

In Book III of the Local Government Code, Title I, Chapter I, Section 385 provides that "A barangay may be created, divided, merged, abolished, or its boundary substantially altered, by law or by an ordinance of the Sangguniang Panlalawigan or Panlungsod, subject to approval by a majority of the votes cast in a plebiscite to be conducted by the COMELEC in the local government unit or units directly affected within such period of time as may be determined by the law or ordinance creating said barangay. In the case of the creation of barangays by the Sangguniang Panlalawigan, the recommendation of the Sangguniang Bayan concerned shall be necessary.

Findings:

The foregoing discussion clearly showed that the Cirmont Avenue, currently, is divided in the middle, with one portion is under the supervision, control and authority of Barangay Real, and the other is under the supervision, control and authority of Barangay Panapaan V. To facilitate an efficient and unified enactment of laws, regulations and the Barangay Ordinances in the said area, Barangay Real hereby relinquishes, abdicates, and cedes its authority over portions of Cirmont Avenue within its territorial jurisdiction in favor of Barangay Panapaan V. To ensure the effectiveness of this relinquishment and abdication, the Sangguniang Panlungsod is mandated by the Local Government Code to enact an appropriate legislative measure to this effect.

The committee hearing was called to order by Coun. Pagulayan, addressing two agenda items. The first, PNO 287-2024, involves the resolution to relinquish Cirmont Avenue of Barangay Real to the control of Barangay Panapaan V. The second, PNO 288-2024, focuses on the resolution to cede Camellia Homes 2F of Barangay Real to Barangay Salinas 2.

The discussion started with Brgy. Capt. Aganus explained the intention behind the turnover of Camellia 2F and the agreement with neighboring barangays. Panapaan V

and Salinas 2 expressed their gratitude and acceptance of the responsibilities associated with the turnover. The City Assessor, Engr. Quinatadcan, and Zoning and Land Development Department representative, Mr. Bautista, provided comments on the proposed changes to clarify boundaries.

The meeting progressed with a detailed discussion led by Coun. Pagulayan, Engr. Quinatadcan, and Mr. Bautista, physically mapping out the proposed changes in boundaries on a diagram. Concerns were addressed, and agreements were made to follow the parcel boundaries and maintain clarity. A suggestion was made to submit an ordinance instead of a resolution for formal approval, and Atty. Valenciano was tasked with facilitating the process. The meeting concluded with assurances from all parties to avoid confusion and ensure a smooth transition. The committee hearing was then adjourned.





WHEREAS, Cirmont Avenue, at present, is divided in the middle, one portion is under the supervision, control and authority of Barangay Real and the other is under the supervision, control and authority of Barangay Panapaan V;

WHEREAS, for an efficient and united enactment of laws, regulations and Barangay Ordinances in the said area, Barangay Real hereby relinquishes, abdicates, and cedes its authority over portions of Cirmont Avenue under its territorial jurisdiction in favor of Barangay Panapaan V;

WHEREAS, in order for the said relinquishment and abdication to be effective, the Sangguniang Panglungsod is mandated by the Local Government Code to enact an appropriate legislative measure to this effect;

WHEREAS, the Barangay Council of Real is requesting the approval of the Sangguniang Panglungsod of the said relinquishment and abdication in favor of Barangay Panapaan V;


THEREFORE, Resolved, as it is hereby resolved by the Sangguniang Barangay in session duly assembled: To request the Sangguniang Panglungsod then the endorsement from the City Mayor Strike B. Revilla, to enact an appropriate legislative measure for the alteration of territorial boundary shared by Barangay Real and Barangay Panapaan V in that the Barangay Real portion of Cirmont Avenue be included in the territorial jurisdiction of Barangay Panapaany V.


