#### COMMITTEE REPORT

Subject: FROM BARANGAY P.F. ESPIRITU 4 – BARANGAY ORDINANCE NO. 01-2024: AN ORDINANCE ON THE ALLOCATION AND UTILIZATION OF THE BARANGAY DISASTER RISK REDUCTION AND MANAGEMENT FUND (BDRRMF) – PNOA-294-S-2024 dated February 19, 2024

Referred to this Committee during the 79<sup>th</sup> Regular Session is the above-subject matter for appropriate action and recommendation.

#### LEGAL BASIS:

Section 21 of Republic Act No. 10121 otherwise known as the "Philippine Disaster Risk Reduction and Management Act of 2010". provides that not less than five per cent (5%) of the estimated revenue from regular sources shall be set aside as the LDRRMF to support disaster risk management activities such as, but not limited to, pre-disaster preparedness programs including training, purchasing life-saving rescue equipment, supplies and medicines, for post-disaster activities, and for the payment of premiums on calamity insurance. The LDRRMC shall monitor and evaluate the use and disbursement of the LDRRMF based on the. LDRRMP as incorporated in the local development plans and annual work and financial plan. Upon the recommendation of the LDRRMO and approval of the sanggunian concerned, the LDRRMC may transfer the said fund to support disaster risk reduction work of other LDRRMCs which are declared under state of calamity.

The same provision is also cited in NDRRMC-DBM-DILG Joint Memorandum Circular (JMC) No. 2013-1 dated March 25, 2013, and we quote "Section 21 of RA No. 10121, the LDRRMF amounting to not less than five percent (5%) of the estimated revenue from regular sources shall be set aside to support disaster risk management activities such as, but not limited to the pre-disaster preparedness programs including training, purchase of disaster response and rescue equipment, supplies and medicines, for post-disaster activities, and payment of premiums on calamity insurance. Of the amount appropriated for LDRRMF, thirty percent (30%) shall be allocated as a lump sum Quick Response Fund (QRF) or stand-by fund for relief and recovery programs in order that situation and living conditions of people in communities or areas stricken by disasters, calamities, epidemics or complex emergencies, may be normalized as quickly as possible."

BARANGAY ORDINANCE NO. 01-2024 SERIES OF 2024

"AN ORDINANCE ON THE ALLOCATION AND UTILIZATION OF THE BARANGAY DISASTER RISK REDUCTION AND MANAGEMENT FUND (BDRRMF)"

WHEREAS; Republic Act No. 10121 Philippine Disaster Risk Reduction and Management Act of 2010 granted local government units greater flexibility towards disaster mitigation, preparation, response, rehabilitation and recovery;

WHEREAS; the Joint Memorandum Circular No. 2013-01 is issued to serve as a guide to LGU in the allocation and used of BDRRMF and to enhance transparency and accountability in the use of the BDRRMF;

WHEREAS; Section 21 of R.A. 10121 provides that the BDRRMF amounting to not less than five percent (5%) of the estimated revenue from regular resources shall be set aside to support disaster risk management activities;

WHEREAS; the BDRRMF shall cover the thirty percent (30%) lump-sum allocation for Quick Response Fund (QRF) and the seventy percent (70%) allocation for disaster prevention and mitigation, preparedness, response, rehabilitation and recovery;

NOW THEREFORE, BE IT ORDAINED AS IT IS HEREBY ORDAINED BY THE SANGGUNIANG BARANGAY OF P.F. ESPIRITU 4 THAT:

Section 1. Policies and Procedure on the Utilization of the BDRRMF:

- a. The appropriation for the BDRRMF shall be included in the Annual Barangay Budget.
- b. The projects and activities to be charge against the BDRRMF shall be incorporated in the Barangay Disaster Risk Reduction and Management Plan (BDRRMP) and integrated in the approved Annual Investment Program.
- c. The release and use of the 30% QRF shall be supported by a resolution of the local sanggunian declaring the LGU under the state of calamity or a Presidential declaration of state of calamity upon recommendation of the NDRRMC.
- d. The unexpected BDRRMF shall accrue to a special trust fund solely for the purpose of supporting disaster risk reduction and management activities of the BDRRMC within the next five years.
- e. The acquisition/availment of disaster risk reduction and management equipment, may be done through rental/leasing from the service provider of such items.
- f. The procurement of supplies and equipment chargeable against the BDRRMF shall be subject to R.A. 9184 (An Act Providing for the Modernization, Standardization, and regulation of the Procurement Activities of the Government and For the Other Purposes) and its Implementing Rules and Regulations.
- g. Monthly and annual report on the utilization of the BDRRMF and approved/revised AIP indicating the disaster risk reduction management projects and activities to be implemented.

#### Section 2. SEPARABILITY CLAUSE.

Any provision of this ordinance that is inconsistent with the existing law shall be repealed but the entirety of the ordinance shall remain in effect and continue to be enforced.
