Subject: **RESOLUTION NO. 02, SERIES OF 2024: A RESOLUTION AUTHORIZING THE BARANGAY LIGAS 2 (FORMER LIGAS 3) TO TRANSFER ITS NATIONAL TAX ALLOTMENT (NTA) DEPOSITORY FROM LANDBANK IMUS BRANCH TO DEVELOPMENT BANK OF THE PHILIPPINES-BACOOOR BRANCH, CITY OF BACOOOR, CAVITE - PNOA 335-2024 dated March 11, 2024**

---

Referred to this Committee on the 82nd Regular Session is the above-subject matter for appropriate action and recommendation.

Barangay Ligas 2 was the resultant barangay in the renaming of former Barangay Ligas 3 pursuant to City Ordinance No. 275-2023 entitled "AN ORDINANCE MERGING VARIOUS BARANGAYS IN THE CITY OF BACOOOR, CAVITE TO ENSURE THEIR ECONOMIC GROWTH AND DEVELOPMENT, RENAMED THE MERGED BARANGAYS AND THE BARANGAYS AFFECTED BY SUCH MERGER, FIXING RESPECTIVE TERRITORIAL BOUNDARIES, AND APPROPRIATING FUNDS FOR THE HOLDING OF PLEBISCITE FOR THE APPROVAL HEREOF MANDATED BY LAW". The Ordinance was duly ratified in a plebiscite held on July 29, 2023.

The barangay resolution (RESOLUTION NO. 02 Series of 2024) approved by the Sangguniang Barangay of Barangay Ligas 2 aimed to transfer its National Tax Allotment (formerly IRA) Depository Account to the Development Bank of the Philippines (DBP) from the Land Bank of the Philippines (LBP) with the information that the Barangay have already secured the required clearance from the Land Bank of Philippines (LBP) for the account of defunct Barangay Ligas 3.

#### **FINDINGS:**

In the transfer of depository bank or change of bank branch involving the Internal Revenue Allotment (now National Tax Allotment), the Department of Budget and Management (DBM) requires a Sanggunian resolution authorizing the transfer and the clearance from the current depository bank allowing such transfer. Likewise, the transfer of depository bank involving the NTA must comply with the guidelines provided by the Bureau of the Treasury under its **Treasury Circular No. 6-2022** issued on November 7, 2022.

**WHEREAS**, as provided from in REPUBLIC ACT NO. 7160 (Otherwise known as the Local Government Code of 1991) Section 389, article (b), said that the Punong Barangay will negotiate, enter into, sign contracts on behalf of the barangay upon the authorization of the Sangguniang Barangay.

**WHEREAS**, on January 1, 2024, Punong Barangay Pablo N. Morales of Barangay Ligas 2, requested the Sangguniang Barangay to transfer its Tax Revenue Allotment (NTA) depository account from Landbank - Imus Branch to Development Bank of the Philippines - Bacoor Branch, City of Bacoor, Cavite;
