Subject: RESOLUTION NO. 09, SERIES OF 2024: A RESOLUTION REQUESTING THE BACOOR CITY TREASURY TO TRANSFER ALL UNEXPENDED TRUST FUND OF NEWLY FORMED BARANGAY PF ESPIRITU 4 TO DEVELOPMENT BANK OF THE PHILLIPPINES, BAYANAN BRANCH, WITH ACCOUNT NO. OF 0-50166-651-3 - PNOA 345-2024 dated March 11, 2024

Referred to the Committee on the 82nd Regular Session is the above-subject matter for appropriate action and recommendation.

Barangay PF Espiritu 4 was the resultant barangay in the merging of former Barangays PF Espiritu 5 and PF Espiritu 6 pursuant to City Ordinance No. 275-2023 entitled "AN ORDINANCE MERGING VARIOUS BARANGAYS IN THE CITY OF BACOOR, CAVITE TO ENSURE THEIR ECONOMIC GROWTH AND DEVELOPMANT, RENAMED THE MERGED BARANGAYS AND THE BARANGAYS AFFECTED BY SUCH MERGER, FIXING RESPECTIVE TERRITORIAL BOUNDARIES, AND APPROPRIATING FUNDS FOR THE HOLDING OF PLEBISCITE FOR THE APPROVAL HEREOF MANDATED BY LAW". The Ordinance was duly ratified in a plebiscite held on July 29, 2023. The defunct Barangays PF Espiritu 5 and 6 have enacted their ordinances creating a trust fund involving their unexpended funds. Likewise, the defunct barangays also approved the resolutions authorizing Barangay PF Espiritu 4 to receive and utilize the said trust funds.

The barangay resolution (RESOLUTION NO. 09, Series of 2024) approved by the Sangguniang Barangay of Barangay PF Espiritu 4 aimed to transfer the said Trust Fund covered by Account No. 0-50166-651 to the Development Bank of the Philippines (DBP) from the Land Bank of the Philippines (LBP).

FINDINGS:

In the transfer of depository bank or change of bank branch involving the funds of the Local Government Units (LGUs), which in this case the barangay fund, the Department of Budget and Management (DBP) requires a Sanggunian resolution authorizing the transfer and the clearance from the current depository bank allowing such transfer.

Honorable Rowena Bautista Mendiola, Presiding Officer called the $82^{\rm nd}$ Regular Session to order.

Khalid Atega, Jr., Secretary of the Sangguniang Panlungsod, proceeded with the roll call, the approval of the Journal and Minutes of the 81st Regular Session, and the reading of the referrals to committees of proposed Ordinances, Resolutions, Messages, Communications, Petitions and Memorials.

On motion by Honorable Rogelio M. Nolasco which was unanimously seconded by the majority of the Honorable Members of Sangguniang Panlungsod, the internal rules were suspended.

Upon reading and referral of Agenda Item No. F.13.1 – PNOA-345-2024 – "RESOLUTION NO. 09 SERIES OF 2024: A RESOLUTION REQUESTING THE BACOOR CITY TREASURY TO TRANSFER ALL UNEXPENDED TRUST FUND OF THE NEWLY FORMED BARANGAY P.F. ESPIRITU 4 TO DEVELOPMENT BANK OF THE PHILIPPINES, BAYANAN BRANCH, WITH AN ACCOUNT NO. OF 0-50166-651-3." Honorable Rogelio M. Nolasco moved the approval for the Resolution No. 09 series of 2024: A resolution requesting the Bacoor City Treasury to transfer all unexpended trust fund of Barangay P.F. Espiritu 4 to Development Bank of the Philippines Bayanan Bacoor Cavite Branch whereas, the former Barangay Panapaan V closed their bank account from Landbank of the Philippines with account no. 1422-1017-60 and former Barangay Panapaan VI closed their bank account from Veterans Bank with account no. 0180000223, all unexpended funds of both barangays that merged under the new name of P.F. Espiritu IV have been transferred to the City of Bacoor Trust fund. The newly formed Barangay P.F. Espiritu IV already opened

an account in Development Bank of the Philippines with an account no. 0-50166-651-3 under the new name of Barangay P.F. Espiritu IV.

The motion was unanimously seconded by the majority of Honorable Members of the 5th Sangguniang Panlungsod. Resolution no. 09 series of 2024: A resolution requesting Bacoor city Treasury to transfer all unexpended trust fund of the newly formed Barangay P.F. Espiritu 4 to Development Bank of the Philippines, Bayanan Branch, with an account no. of 0-50166-651-3 was **APPROVED**.

The regular session was closed and adjourned at 12:10 P.M.

BARANGAY RESOLUTION NO. 09 SERIES OF 2024

"A RESOLUTION REQUESTING THE BACOOR CITY TREASURY TO TRANSFER ALL UNEXPENDED TRUST FUND OF THE NEWLY FORMED BARANGAY P.F. ESPIRITU 4 TO DEVELOPMENT BANK OF THE PHILIPPINES, BAYANAN BRANCH, WITH AN ACCOUNT NO. OF 0-50166-651-3"

WHEREAS, on 29 July 2023, a plebiscite was conducted pursuant to City Ordinance No. 275-2023 to ratify the merging and renaming of various barangays in the City of Bacoor, Cavite, and 90.44% of the votes consisted of YES votes;

WHEREAS, by virtue of the successful ratification, <u>Barangay Panapaan V</u>, <u>along with</u> Barangay Panapaan VI are merged together and are now renamed Barangay P.F. <u>Espiritu 4</u>;

WHEREAS, Section 8 of the said Ordinance provides that the income and funds of the merged barangays shall be transferred to the new barangays mentioned in section 2 hereof pursuant to relevant government regulations. The City Budget Officer, the City Treasurer and the City Accountant of the Bacoor City Government are hereby empowered and directed to assist the affected barangays in the implementation of this provision;

WHEREAS, the former Barangay Panapaan V closed their bank account to the Landbank of the Philippines with an account no. of 1422-1017-60 last December 18, 2023 and former Barangay Panapaan VI closed their bank account to the Veterans Bank with an account no. 0180000223 last January 5, 2024;

WHEREAS, upon the closure of bank account of former Barangay Panapaan V and Barangay Panapaan 6, all unexpended funds of both former barangays have been transferred to the City of Bacoor Trust Fund;
