### COMMITTEE REPORT NO. FBA 269-S-2024

Subject: FROM BARANGAY SINBANALI: RESOLUTION NO. 2024-006: A RESOLUTION REQUESTING FOR THE TRANSFER OF OUR BARANGAY IRA DEPOSITORY ACCOUNT FROM THE LANDBANK OF THE PHILIPPINES TO DEVELOPMENT BANK OF THE PHILIPPINES BACOR BRANCH – PNOA 351-2024 dated March 11, 2024

Referred to the Committee on the 82<sup>nd</sup> Regular Session is the above-subject matter for appropriate action and recommendation.

Barangay **SINBANALI** was the resultant barangay in the merging of former Barangays Sineguelasan, Banalo and Alima pursuant to City Ordinance No. 275-2023 entitled "AN ORDINANCE MERGING VARIOUS BARANGAYS IN THE CITY OF BACOR, CAVITE TO ENSURE THEIR ECONOMIC GROWTH AND DEVELOPMENT, RENAMED THE MERGED BARANGAYS AND THE BARANGAYS AFFECTED BY SUCH MERGER, FIXING RESPECTIVE TERRITORIAL BOUNDARIES, AND APPROPRIATING FUNDS FOR THE HOLDING OF PLEBISCITE FOR THE APPROVAL HEREOF MANDATED BY LAW.". The Ordinance was duly ratified in a plebiscite held on July 29, 2023.

The barangay resolution (RESOLUTION NO. 2024-006) approved by the Sangguniang Barangay of **Barangay Sinbanali** aimed to transfer its National Tax Allotment (formerly IRA) Depository Account to the Development Bank of the Philippines (DBP) from the Land Bank of the Philippines (LBP) with the information that the Barangay have already secured the required clearances from the Land Bank of Philippines (LBP) for the accounts involving the defunct Barangays Sineguelasan, Banalo and Alima.

#### FINDINGS:

In the transfer of depository bank or change of bank branch involving the Internal Revenue Allotment (now National Tax Allotment), the Department of Budget and Management (DBM) requires a Sanggunian resolution authorizing the transfer and the clearance from the current depository bank allowing such transfer. Likewise, the transfer of depository bank involving the NTA must also comply with the guidelines provided by the Bureau of the Treasury (BTr) under its **Treasury Circular No. 6-2022 issued on November 7, 2022.**


**RECOMMENDATION:**
