Subject: RESOLUTION NO. 4 SERIES OF 2024: A RESOLUTION AUTHORIZING THE PUNONG BARANGAY OF MERGED AND SURVIVING BARANGAY ZAPOYE 2 EDWIN CABRERA TORRES , TO REQUEST FROM THE CITY MAYOR STRIKE B. REVILLA OF BACoor TO RELEASE OF FUNDS (TSTF) OF THE ABSORBED BARANGAY ZAPOTE 2, STATING ITS PURPOSE OF MODE OF DISBURSEMENT AND TO RECEIVE THE SAID FUNDS (TSTF) REQUESTED, FURTHER TO SUBMIT TO CITY MAYOR THE PROPOSED BUDGET OF MERGED AND ENLARGED BARANGAY ZAPOTE 2 IN ACCORDANCE WITH PROPOSED BUDGET FOR DECEMBER 2023 OF BARANGAY ZAPOTE 3 AND ZAPOTE 4 AS MERGED AND COMBINED. – PNOA 355-2024 dated March 11, 2024

Referred to this Committee on the 82nd Regular Session is the above-subject matter for appropriate action and recommendation.

Barangay ZAPOTE 2 was the resultant barangay in the merging of former Barangays Zapote 3 and Zapote 4 pursuant to City Ordinance No. 275-2023 entitled "AN ORDINANCE MERGING VARIOUS BARANGAYS IN THE CITY OF BACoor, CAVITE TO ENSURE THEIR ECONOMIC GROWTH AND DEVELOPMANT, RENAMED THE MERGED BARANGAYS AND THE BARANGAYS AFFECTED BY SUCH MERGER, FIXING RESPECTIVE TERRITORIAL BOUNDARIES, AND APPROPRIATING FUNDS FOR THE HOLDING OF PLEBISCITE FOR THE APPROVAL HEREOF MANDATED BY LAW.". The Ordinance was duly ratified in a plebiscite held on July 29, 2023.

The barangay resolution (RESOLUTION NO. 4, Series of 2024) as approved by the Sangguniang Barangay of Barangay Zapote 2 aimed to request the City Mayor to release the funds (TSTF) of the defunct barangays, receive the same by the Punong Barangay, and utilize/disburse said funds for the purpose intended and stated in the barangay resolution.

A RESOLUTION AUTHORIZING THE PUNONG BARANGAY OF MERGED AND SURVIVING BARANGAY ZAPOTE 2 EDWIN CABRERA TORRES, TO REQUEST FROM CITY MAYOR STRIKE B. REVILLA OF BACOR TO RELEASE OF FUNDS (TSTF) OF THE ABSORBED BARANGAY ZAPOTE 2. STATING ITS PURPOSE OF MODE OF DISBURSEMENT AND TO RECEIVE THE SAID FUNDS (TSTF) REQUESTED. FURTHER TO SUBMIT TO CITY MAYOR THE PROPSD BUDGET OF MERGED AND ENLARGED BARANGAY ZAPOTE 2 FOR DECEMBER 2023 IN ACCORDANCE WITH THE PROPSD BUDGET FOR DECEMBER 2023 OF BARANGAY ZAPOTE 3 AND BARANGAY ZAPOTE 4 AS MERGED AN COMBINED.

WHEREAS, on July 29, 2023 a plebiscite was conducted pursuant to City Ordinance No. 275-2023 ratify the merging consolidation and renaming of various barangays in the City of Bacoor, Cavite. Around 90.44% of the voters consisted of yes votes.

WHEREAS, by virtue of successful ratification, Barangay Zapote 3 and Barangay Zapote 4 were merged as one barangay. The Barangay Zapote 2 is the surviving and enlarged barangay local government unit or public corporation.

WHEREAS, considering the merging of two barangay with Barangay Zapote 2 as the surviving and enlarged barangay, the appropriated funds accruing to the absorbed Barangay Zapote 3 will no longer be available for disbursement of their respective budget for the salaries of the Barangay Officials and employees, deliver of basic services, payment for the Barangay utilities and most of all to the benefit of the constituents of the surviving and enlarged Barangay Zapote 2.

WHEREAS, the population, territory and other political details of the surviving and enlarged Barangay Zapote 2 is the same as that of Barangay Zapote 2 and Barangay Zapote 3 as merged and combined.

WHEREAS, the Sangguniang Barangay of Barangay Zapote 3 are mindful of the above mentioned circumstances and the provision of law cited above, thereby enacted of Barangay Zapote 3 Ordinance No. 5 Series of 2023 effectivity date on November 15, 202. This is to ensure that the incoming and surviving Barangay Zapote 2 will receive much needed funding for the best serve the constituents of the same to include the constituents of those Barangay Zapote 3 which ceased to exist on December 1, 2023. (Upon Barangay Zapote 2 pursuant to Sec. 14 of R.A 7160 absorbing Barangay Zapote 3.)
