Subject: APPROPRIATION ORDINANCE NO. 02-2023: ANNUAL GENERAL FUND OF BARANGAY ANIBAN II FOR CALENDAR YEAR 2024 IN THE AMOUNT OF PHP7,635,890.00 - PNOA-376-S-2024 dated March 18, 2024

Referred to this Committee during the 83nd Regular Session is the above-subject matter for appropriate action and recommendation.

Consistent with the approved 2024 Annual Investment Program and DILG approved GAD Plan for Fiscal Year 2024, the Sangguniang Barangay of ANIBAN II enacted Ordinance No. 02-2023 approving the 2024 Annual General Fund to cover the Personal Services (PS), Maintenance and Other Operating Expenses (MOOE), Capital Outlay (CO) and Special Purpose Allocation (SPA) which involved the total amount of SEVEN MILLION SIX HUNDRED THIRTY-FIVE THOUSAND EIGHT HUNDRED NINETY PESOS (PHP7,635,890.00).

The attached documents to support the proposed Annual General Fund will readily show that it has been examined and reviewed by the concerned City Accounting Office and City Budget Office and that the same is in conformity with the provisions of Republic Act No. 7160 and existing budget circulars/issuances.

Upon the suspension of internal rules and referral to this Committee of said Barangay Ordinance No. 02-2023, Honorable Rogelio M. Nolasco moved for the approval of the same and the motion was unanimously seconded by the majority of the Honorable Members of the 5th Sangguniang Panlungsod. The Annual General Fund for Fiscal Year 2024 of Barangay ANIBAN II, Bacoor City for FY2024 was APPROVED, charge to its Receipt Program.

RECOMMENDATION:

In view of the foregoing, the Honorable Members of the Committee hereby recommend TO APPROVE the Appropriation Ordinance authorizing the Barangay Annual General Fund of Barangay ANIBAN II, Bacoor City in the total amount of SEVEN MILLION SIX HUNDRED THIRTY-FIVE THOUSAND EIGHT HUNDRED NINETY PESOS (PHP7,635,890.00), subject to the existing accounting and auditing rules and regulations.

Nolasco moved the approval for the Appropriation Ordinance No. 02-003 for the Annual General Fund for Barangay Aniban II for the calendar year 2024 in the amount of PHP 7,635,890.00 Following the recommendation of City Budget Officer the annual budget has not exceeded the estimates income for the year. And the Barangay AIP is in accordance with the projected programs and included in annual budget.

This refers to the FY 2024 Annual General Fund Budget of Barangay Aniban II involving an appropriation of P 7,635,890.00 passed and approved under Sangguniang Barangay Appropriation Ordinance No.02-2023 on December 22, 2023 and received by this Office for review and evaluation.

Preliminary review of the submitted budget has been undertaken pursuant to Republic Act. No. 7160 and other related issuances; the following are our findings and recommendation as basis for

1 The aggregate amount appropriated in the annual budget has not exceeded the estimates of

Appropriation for development projects is set at P 1,321,178.00 which is equivalent to 20% of estimated NTA for the budget year. Utilization of the said fund is covered by DBM-DOF- DILG Joint Memorandum Circular No.1 dated Nov. 4, 2020.

3. Appropriation for Barangay Disaster Risk Reduction and Management Fund (BDRRMF) is set at 5% of the estimated revenue from regular sources. Disbursements thereof shall be in accordance with RA 10121 otherwise known as Philippine Disaster Risk Reduction and Management Act of 2010. The attached BDRRM Plan shows the distribution of the fund as per RA 10121.

SK fund was provided at 10% of the estimated revenue from regular sources.

BCPC Fund was provided at 1% of NTA for the budget year as mandated by RA 9344 for the strengthening and implementation of the programs of the council


