REVILLA OF BACOR TO RELEASE OF FUNDS (TSTF) OF THE ABSORBED BARANGAY PANAPAAN 5 AND BARANGAY PANAPAAN 6 STATING ITS PURPOSE OF MODE OF DISBURSEMENT AND TO RECEIVE THE SAID FUNDS (TSTF) REQUESTED, FURTHER TO REQUEST THE CITY MAYOR TO TRANSFER ALL UNEXPENDED FUNDS (TSTF) TO THE DEVELOPMENT BANK OF THE PHILIPPINES BAYANAN BRANCH UNDER THE ACCOUNT NAME BARANGAY P.F. ESPIRITU 4 WITH AN ACCOUNT OF 0-50166-651-3. – PNOA 388-2024 dated March 18, 2024**

Referred to this Committee on the 83<sup>rd</sup> Regular Session is the above-subject matter for appropriate action and recommendation.

**Barangay P.F. ESPIRITU 4** was the resultant barangay in the merging of former Barangays **PANAPAAN 5** and **PANAPAAN 6** pursuant to City Ordinance No. 275-2023 entitled "AN ORDINANCE MERGING VARIOUS BARANGAYS IN THE CITY OF BACOR, CAVITE TO ENSURE THEIR ECONOMIC GROWTH AND DEVELOPMENT, RENAMED THE MERGED BARANGAYS AND THE BARANGAYS AFFECTED BY SUCH MERGER, FIXING RESPECTIVE TERRITORIAL BOUNDARIES, AND APPROPRIATING FUNDS FOR THE HOLDING OF PLEBISCITE FOR THE APPROVAL HEREOF MANDATED BY LAW.". The Ordinance was duly ratified in a plebiscite held on July 29, 2023.

The barangay resolution (**RESOLUTION NO. 11, Series of 2024**) as approved by the Sangguniang Barangay of Barangay **P.F. ESPIRITU 4** aimed to request the City Mayor to release the funds (TSTF) of the defunct barangays, receive the same by the Punong Barangay, and utilize/disburse said funds for the purpose intended and stated in the barangay resolution, and to transfer the unexpended funds (TSTF) to the Development Bank of the Philippines, Bayanan Branch under the account name Barangay P.F. Espiritu with account number 0-50166-651-3.

WHEREAS, on 29 July 2023, a plebiscite was conducted pursuant to City Ordinance No. 275-2023 to ratify the merging and renaming of various barangays in the City of Bacoor, Cavite, and 90.44% of the votes consisted of YES votes;

WHEREAS, by the virtue of successful ratification, Barangay Panapaan 5 and Barangay Panapaan 6 were merged as one barangay. The Barangay P.F. Espiritu 4, is the newly formed barangay local government unit or public corporation;

WHEREAS, considering the merging of two barangays, Barangay P.F. Espiritu 4 is the newly formed barangay of former Barangay Panapaan 5 and Barangay Panapaan 6, the appropriated funds accruing to former barangays will no longer be available for disbursement of their respective budget for the salaries of the Barangay Officials and Employees, deliver of basic services, payment for the barangay utilities and most of all the benefit of the constituents of the newly formed Barangay P.F. Espiritu 4;

WHEREAS, the population, territory, and other political details of the newly formed Barangay P.F. Espiritu 4 are the same as that of Barangay Panapaan V and Barangay Panapaan VI as merged;
