Subject: BARANGAY P.F ESPIRITU 6: RESOLUTION NO. 24-08 SERIES OF 2024: RESOLUTION GRANTING AUTHORITY TO HON. FERDINAND S. BARBA TO SIGN DOCUMENTS ON BEHALF OF THE BARANGAY P.F. ESPIRITU 6. (PNOA-389-2024 dated March 18, 2024)

Barangay P.F Espiritu 6 has submitted Resolution No. 24-08, Series of 2024, requesting the approval of the Sangguniang Panlungsod ng Bacoor. The resolution seeks to grant Hon. Ferdinand S. Barba, Punong Barangay, the authority to sign documents on behalf of the Barangay.





RESOLUTION GRANTING AUTHORITY TO THE HON. FERDINAND S. BARBA TO SIGN DOCUMENTS ON BEHALF OF BARANGAY P.F. ESPIRITU 6

WHEREAS, the Barangay P.F. Espiritu 6, City of Bacoor, Cavite, is mandated to perform various functions and duties for the welfare and development of its constituents;

WHEREAS, there is a need for a designated official to have the authority to sign documents, contracts, agreements and other pertinent papers on behalf of the Barangay;

NOW THEREFORE, BE IT IS RESOLVED as it is hereby resolved, by the Sangguniang Barangay of P.F. Espiritu 6, in a session assembled, that:

Section 1. AUTHORITY TO SIGN DOCUMENTS

The Hon. FERDINAND 5. BARBA being the Punong Barangay of P.F. Espiritu 6, city of Bacoor, Cavite, is hereby granted the authority to sign, execute and deliver all documents, contracts, agreements, and papers necessary for and on behalf of the barangay, subject to limitations and guidelines set by the Sangguniang Barangay,

Section 2. SCOPE OF AUTHORITY

The authority granted to Hon. FERDINAND S. BARBA shall include, but is not limited to the following:

- Signing official correspondence and communications;
- Executing contracts, agreements, and Memorandum of Agreements by and between Barangay government of P.F. Espiritu 6 and MWEEB, Inc.

Section 3. LIMITATIONS

The authority granted herein is subject to the following limitation:

- The Hon. Ferdinand S. Barba shall not sign any document that is in violation of existing laws, ordinances and policies;
- The Sangguniang Barangay reserve the right to revoke or amend this authority as deemed necessary.

Section 4. EFFECTIVITY

This resolution shall take effect immediately upon approval,
