Hon. Mayor Strike B. Revilla introduced the Systematized Barangay Records (SBR) to improve the quality of services provided to the public by reducing the amount of time required to process applications and requests, pay for them, and issue clearances, barangay IDs, certificates, and other barangay records. Barangay San Nicolas II is committed to promoting timely actions and efficient resolution of all government transactions, in accordance with Republic Act 11032, also referred to as "The Ease of Doing Business Law," which seeks to simplify the existing government service systems and procedures.

FINDINGS:

The Barangay San Nicolas I has identified a need to enhance their record-keeping processes. In response, the council passed a resolution authorizing Punong Barangay Alfredo Kalinisan to enter into a Memorandum of Agreement with MWEEB, Inc. a company specializing in systematized record management solutions. This is a necessary step towards modernizing the barangay's record management system will bring significant improvements in terms of efficiency, accuracy, and accessibility of barangay records. The expected benefits of the SBR system include increased efficiency in handling barangay records, improved data accuracy, and enhanced accessibility for barangay officials and constituents.

RECOMMENDATION:

After thorough discussion and consideration, the Barangay Affairs Committee unanimously **APPROVED** Barangay Resolution No. 2024-003. The implementation of the Systematized Barangay Records (SBR) system will greatly enhance the efficiency and effectiveness of record management in Barangay San Nicolas 1, benefiting both the administration and its constituents.

WHEREAS, Section 389, Chapter III, Title I of Republic Act 7160 otherwise known as The Local Government Code of 1991 states under paragraph (b) no. (2) that the punong barangay, as the chief executive of the barangay government, shall negotiate, enter into, and sign contracts for and in behalf of the barangay, upon authorization of the sangguniang barangay, no. (8) of the same provision states to approve vouchers relating to the disbursement of barangay funds, no. (12) ensures the delivery of basic services as mandated under Section 17 of the same code, and under no. (14) the Punong Barangay shall promote the general welfare of the

WHEREAS, Section 391, Chapter IV, Title I of Republic Act 7160 under paragraph (a) no. (12) provides that the sangguniang barangay, as the legislative body of the barangay, shall authorize the punong barangay to enter into contracts in behalf of the barangay, subject to the provisions of the Local Government Code of 1991 ;

WHEREAS, Republic Act 11032 or otherwise known as *"The Ease of Doing Business Law"* aims to streamline the current systems and procedures of government services wherein the law is poised to facilitate prompt actions or resolution of all government transactions with efficiency;

WHEREAS, the City Government of Bacoor through the leadership of Mayor Strike B. Revilla have introduced a Systematized Barangay Records (SBR) that would escalate the type of services rendered to the public in terms of issuance of clearances, Barangay I.D.s, Certificates and other Barangay Records with ease and with minimal time consumed from the receipt of an application or request to its payment and issuance;

WHEREAS, the Sangguniang Barangay of San Nicolas 1 finds the Systematized Barangay Records to be necessary since it will be a very important part of the Barangay's document management policies. It will help the Barangay to systematically manage records throughout its cycle. It can effectively retrieve and dispose records as a well-designed filing system and can have complete access to accurate information in a timely and cost-effective manner;

WHEREAS, MWEEB Inc. is a software company with Front-End Web Developers that specializes in Information Technology Services and Developing Application Programs;


