





RESOLUTION GRANTING AUTHORITY TO JONNEL T. EUSEBIO TO SIGN DOCUMENTS ON BEHALF OF THE BARANGAY SAN NICOLAS II AND MWEEB, INC.

WHEREAS, the Barangay San Nicolas II, City of Bacoor, Cavite, is mandated to perform various functions and duties for the welfare and development of its constituents;

WHEREAS, there is a need for a designated official to have the authority to sign documents, contracts, agreements, and other pertinent papers on behalf of the Barangay;

NOW, THEREFORE, BE IT RESOLVED, as it is hereby resolved, by the Barangay San Nicolas II, Barangay Council in session assembled, that:

SECTION 1. AUTHORITY TO SIGN DOCUMENTS

Hon. Jonnel T. Eusebio, Punong Barangay of Barangay San Nicolas II, City of Bacoor, Cavite, is hereby granted the authority to sign, execute, and deliver all documents, contracts, agreements, and papers necessary for and on behalf of the Barangay, subject to the limitations and guidelines set by the Barangay Council.

SECTION 2. SCOPE OF AUTHORITY

The authority granted to Hon. Jonnel T. Eusebio shall include, but is not limited to, the following:

Signing official correspondence and communications.

Executing contracts, agreements, and Memorandum Of Agreements by and between Barangay San Nicolas II and MWEEB Inc.

SECTION 3. LIMITATIONS

The authority granted herein is subject to the following limitations:

Hon. Jonnel T. Eusebio shall not sign any document that is in violation of existing laws, ordinances, and policies.
