The above-mentioned subject matter underwent first reading on March 25, 2024 during the 84<sup>th</sup> Regular Session of the Sangguniang Panlungsod. The said subject matter was referred by the Presiding Officer, Bacoor City Vice Mayor Hon. Rowena Bautista Mendiola to the Committee on Health and Sanitation.

**FINDINGS:**

A resolution adopting the NCC Governing Board Resolution No. 2 Series of 2012 entitled "Approving the revised implementing guidelines on Operation Timbang Plus (OPT Plus), with the concurrence of the members of Sangguniang Barangay of Mambog 2 was passed during their Regular Session held last March 7, 2024.

Operation Timbang Plus is the annual mass weighing with the addition of the measurement of length or height of all pre-school children aged 0-71 months old in a community to identify and locate families with malnourished pre-school children and determine the overall nutrition situation in the area every 1<sup>st</sup> quarter of the year.

By the motion of Hon. Reynaldo C. Palabrica duly seconded by all the members of the Sangguniang Panlungsod, the above subject matter was **APPROVED** during its 84<sup>th</sup> Regular Session.




