Subject: RESOLUTION NO. 2024-005: A resolution adopting the NCC Governing Board Resolution No. 1 Series of 2009 entitled "Adopting the National Policy on Nutrition Management in Emergencies and Disaster"

The above-mentioned subject matter underwent first reading on March 25, 2024 during the 84th Regular Session of the Sangguniang Panlungsod. The said subject matter was referred by the Presiding Officer, Bacoor City Vice Mayor Hon. Rowena Bautista Mendiola to the Committee on Health and Sanitation.

### FINDINGS:

A resolution adopting the NCC Governing Board Resolution No. 1 Series of 2009 entitled "Adopting the National Policy on Management in Emergencies and Disasters, with the concurrence of the members of Sangguniang Barangay of Mambog 2 was passed during their Regular Session held last March 7, 2024.

The human-induced emergencies disrupt the lives of populations affected, putting them at risk of developing various undesirable health and related conditions, including those that threaten the national status of individuals especially the most vulnerable groups, infants and children, pregnant women and breastfeeding mothers, older persons, people with disabilities and people living with debilitating conditions.
