Subject: **RESOLUTION NO. 2024-008: A resolution adopting Republic Act No. 11037 entitled "An Act Institutionalizing National Feeding Program for Undernourished Children in Public Day Care, Kindergarten and Elementary Schools to Combat Hunger and Undernutrition among Filipino Children and Appropriating Funds Therefor", otherwise known as "Masustansyang Pagkain para sa Batang Filipino Act."**

The above-mentioned subject matter underwent first reading on March 25, 2024 during the 84<sup>th</sup> Regular Session of the Sangguniang Panlungsod. The said subject matter was referred by the Presiding Officer, Bacoor City Vice Mayor Hon. Rowena Bautista Mendiola to the Committee on Health and Sanitation.

**FINDINGS:**

A resolution adopting Republic Act No. 11037 entitled "An Act Institutionalizing National Feeding Program for Undernourished Children in Public Day Care, Kindergarten and Elementary Schools to Combat Hunger and Undernutrition among Filipino Children and Appropriating Funds Therefor", otherwise known as "Masustansyang Pagkain para sa Batang Filipino Act.", with the concurrence of the members of Sangguniang Barangay of Mambog 2 was passed during their Regular Session held last March 7, 2024.

The program has the following components and coverage: Supplemental Feeding for Day Care Children, School-Based Feeding Program; Milk Feeding Program; Micronutrient Supplements; Health Examination; Vaccination, Deworming; Gulayan sa Paaralan; Water, Sanitation, and Hygiene (WASH); and Integrated Nutrition Education, Behavioral Transformation, and Mobilization.

**RECOMMENDATION:**

By the motion of Hon. Reynaldo C. Palabrica duly seconded by all the members of the Sangguniang Panlungsod, the above subject matter was **APPROVED** during its 84<sup>th</sup> Regular Session.

The 84<sup>th</sup> Regular Session was held last March 25, 2024 at the Session Hall of the Sangguniang Panlungsod. Bacoor City Vice Mayor Hon. Rowena Bautista Mendiola presided the Regular Session and was called to order at exactly 10:00 a.m.
