

Subject: RESOLUTION NO. 2024-008: A resolution adopting Republic Act No. 11037 entitled "An Act Institutionalizing National Feeding Program for Undernourished Children in Public Day Care, Kindergarten and Elementary Schools to Combat Hunger and Undernutrition among Filipino Children and Appropriating Funds Therefor", otherwise known as "Masustansyang Pagkain para sa Batang Filipino Act."

The above-mentioned subject matter underwent first reading on March 25, 2024 during the 84th Regular Session of the Sangguniang Panlungsod. The said subject matter was referred by the Presiding Officer, Bacoor City Vice Mayor Hon. Rowena Bautista Mendiola to the Committee on Health and Sanitation.

FINDINGS:

A resolution adopting Republic Act No. 11037 entitled "An Act Institutionalizing National Feeding Program for Undernourished Children in Public Day Care, Kindergarten and Elementary Schools to Combat Hunger and Undernutrition among Filipino Children and Appropriating Funds Therefor", otherwise known as "Masustansyang Pagkain para sa Batang Filipino Act.", with the concurrence of the members of Sangguniang Barangay of Mambog 2 was passed during their Regular Session held last March 7, 2024.

The program has the following components and coverage: Supplemental Feeding for Day Care Children, School-Based Feeding Program; Milk Feeding Program; Micronutrient Supplements; Health Examination; Vaccination, Deworming; Gulayan sa Paaralan; Water, Sanitation, and Hygiene (WASH); and Integrated Nutrition Education, Behavioral Transformation, and Mobilization.

RECOMMENDATION:

By the motion of Hon. Reynaldo C. Palabrica duly seconded by all the members of the Sangguniang Panlungsod, the above subject matter was **APPROVED** during its 84th Regular Session.

EXCERPT FROM THE MINUTES OF REGULAR SESSION CHS-PNOA-412-2024

Subject: RESOLUTION NO. 2024-008: A resolution adopting Republic Act No. 11037 entitled "An Act Institutionalizing National Feeding Program for Undernourished Children in Public Day Care, Kindergarten and Elementary Schools to Combat Hunger and Undernutrition among Filipino Children and Appropriating Funds Therefor", otherwise known as "Masustansyang Pagkain para sa Batang Filipino Act."

The 84th Regular Session was held last March 25, 2024 at the Session Hall of the Sangguniang Panglungsod. Bacoor City Vice Mayor Hon. Rowena Bautista Mendiola presided the Regular Session and was called to order at exactly 10:00 a.m.

Atty. Khalid Atega, Jr., Secretary of the Sangguniang Panlungsod proceeded with the roll call, the approval of the Journal and minutes of the 83rd Regular Session, and the reading of the referrals to committees of proposed Ordinances, Resolutions, Messages, Communications, Petitions and Memorials.

City Councilor Honorable Rogelio Nolasco moved for the suspension of the internal rules duly seconded by the members of the Sangguniang Panlungsod, the internal rules were suspended.
