FINDINGS:

A resolution Approving and Adopting the Barangay Nutrition Action Plan (BNAP) for CY-2023-2026 of Barangay Talaba 2 to the Barangay Development Council for Adoption and Implementation of Annual Investment Program for CY 2023-2026, with the concurrence of the members of Sangguniang Barangay of Mambog 2 was passed during their Regular Session held last March 19, 2024.

The Barangay Nutrition and Action Plan (BNAP) is a three-year plan containing the objectives and nutrition intentions implemented to address the malnutrition problems at barangay level. It is prepared by the Barangay Nutrition Council and ensures the implementation of its projects and activities.
