COMMITTEE HEARING REPORT NO. PTTM-102-2024

Subject: AN ORDINANCE ADOPTING AND IMPLEMENTING CITY ORDINANCE NO. 47-2019: AUTHORIZING THE CLEARING OF ALL SIDEWALKS, ROADS, STREETS AND THOROUGHFARES IN BARANGAY HABAY II AND PROVIDING PENALTIES HEREOF. (PNOA 430-2024 dated April 01, 2024)

The 85th regular session of the 5th Sangguniang Panlungsod held on April 01, 2024 and referred the subject matter to the Committee on Public Transportation and Traffic Management.

FINDINGS:

The Ordinance is intended to achieve the following:

- Effectively implement DILG Memorandum Circular No. 2019-121 mandating government units to reclaim public roads, sidewalks, streets and thoroughfares and clear them of illegal structures.
- Implement City Ordinance No. 47-2019 also known as the Road Clearing Ordinance of the City of Bacoor along the streets, roads and sidewalks in Barangay Habay II.
- To deter the existing problem of the Barangay Habay II regarding clearance of streets, sidewalks and roads in the Barangay.

RECOMMENDATION:

Barangay Ordinance No. 2024 – 001

AN ORDINANCE ADOPTING AND IMPLEMENTING CITY ORDINANCE NO. 47-2019: AUTHORIZING THE CLEARING OF ALL SIDEWALKS, ROADS, STREETS AND THOROUGHFARES IN BARANGAY HABAY II AND PROVIDING PENALTIES HEREOF

BE IT ORDAINED AS IT IS HEREBY ORDAINED BY THE SANGGUNIANG BARANGAY of HABAY II, CITY OF BACOOR, PROVINCE OF CAVITE THAT:

Section 1. Title: This Ordinance shall be known as "AN ORDINANCE ADOPTING AND IMPLEMENTING CITY ORDINANCE NO. 47-2019 FOR BARANGAY HABAY II"

Section 2. Purpose: This Ordinance is intended to achieve the following:

- 2.1. Effectively implement DILG Memorandum Circular No. 2019-121 mandating government units to reclaim public roads, sidewalks, streets and thoroughfares and clear them of illegal structures,
- 2.2. Implement City Ordinance No. 47-2019 also known as the Road Clearing Ordinance of the City of Bacoor along the streets, roads and sidewalks in Barangay Habay II,
- 2.3. To deter the existing problem of the Barangay Habay II regarding clearance of streets, sidewalks and roads in the Barangay.

Section 3. Cancellation of Permits and Clearances:

- 3.1. Inform and request the City Government of Bacoor specifically the Business Permit and Licensing Office for business permit cancellation of a particular business establishment violating such ordinance after maximum offense/penalties.
- 3.2. Cancel automatically the Barangay Business Clearance issued to the business establishment violating said ordinance.

Section 4. Authority to Remove Obstructions. The authorized Barangay Habay II Peace Corp and Barangay Officials are hereby empowered to remove all illegally constructed structures along prohibited streets, roads and sidewalks of Barangay Habay II.

Section 5. Ban on Parking. The parking of all types of vehicles on the following streets, roads and sidewalks are hereby prohibited:

1. Main road of Barangay Habay II: from Tirona Highway traversing Rosalia St., Sagana Avenue, Isla Noah Road, Reyville Ave. exiting Emilio Aguinaldo Highway.
2. Sagana: Narra Street from South to North.
3. Manggahan: from Yakal – Tindalo to Manggahan II Street, Squala and Saulog Streets.
4. All sidewalks in all subdivision, villages and sitios under the jurisdiction of Habay II.

Section 6. Authority to Tow or Clamp Illegally Parked Vehicles. The Barangay Peace Corp is hereby empowered to tow or clamp all motor vehicles illegally parked in those streets, roads and sidewalks stated in the preceding section of this ordinance.

Section 7. Penal Provision. Section 7 of the City Ordinance 47-2019 is hereby adopted and shall be imposed for any violation.

Section 8. PENALTY. Any person or business establishment who violates any provision of this ordinance shall pay the fine of:

8.1.	First Offense	200.00
8.2.	Second Offense	500.00
8.3.	Third Offense	1,000.00

Section 9. ACCRUAL OF FINES. Fines collected from violators of this Ordinance shall accrue to the General Fund of the apprehending office provided that the latter shall issue corresponding receipt.

Section 10. Separability Clause. – in case any provision of this Ordinance is found void by a court of law, the other provisions hereof not affected by such declaration shall remain valid.

Section 11. Repeal Clause. – all ordinances, resolutions executive orders, memoranda or circulars not consistent with the provisions of this Ordinance are hereby repealed, modified or amended.

Section 12. Effectivity Clause. This ordinance shall become effective fifteen (15) days after it has been disseminated and issued to all organizations, displayed and posted in the conspicuous places of the barangay for proper information and dissemination, after the Sangguniang Barangay has approved it.
