Subject: **RESOLUTION NO. 007 – SERIES OF 2024: RESOLUTION APPROVING THE SANGGUNIANG KABATAAN (SK) OF BARANGAY LIGAS I ANNUAL BUDGET FOR CY 2024 AMOUNTING TO ONE MILLION ONE HUNDRED EIGHTY-THREE THOUSAND SIX HUNDRED FIFTY-SEVEN PESOS AND TWENTY CENTAVOS (PHP1,183,657.20) – PNOA 435-2024 dated April 15, 2024**

---

Referred to this Committee on the 86<sup>th</sup> Regular Session is the above-subject matter for appropriate action and recommendation.

Section 329 of Republic Act No. 7160 otherwise known as the "Local Government Code of 1991", provides that, and we quote:

"SECTION 329. Barangay Funds. – Unless otherwise provided in this Title, all the income of the barangay from whatever source shall accrue to its general fund and shall, at the option of the barangay concerned, be kept as trust fund in the custody of the city or municipal treasurer or be deposited in a bank, preferably government-owned, situated in or nearest to its area of jurisdiction. Such funds shall be disbursed in accordance with the provisions of this Title. Ten percent (10%) of the general fund of the barangay shall be set aside for the **sangguniang kabataan.**"

While the Sangguniang Kabataan is financially independent in its operations, disbursements, and encashment of its funds, income, and expenditures the Committee adheres to the provisions of the Revised Implementing Rules and Regulations (IRR) of Republic Act No. 10742, as amended, and hereunder quoted for ready reference:

"REVISED RULES AND REGULATIONS IMPLEMENTING REPUBLIC ACT (RA) NO. 10742, OTHERWISE KNOWN AS THE "SANGGUNIANG KABATAAN REFORM ACT OF 2015," AS AMENDED BY RA NO. 11768

(d) The appointed SK treasurers shall undergo mandatory bookkeeping training from, and **must be duly certified by the Technical Education and Skills Development Authority (TESDA)** before the assumption of office. Provided that, the mandatory bookkeeping training shall be in addition to the mandatory training under Section 31 of this Rules. Provided further, that only the certification from TESDA shall be considered for purposes of appointment as SK treasurer. Provided finally, that the appointed SK treasurers shall be prioritized in the allocation of appropriate TESDA scholarships in accordance with the guidelines to be issued by the TESDA for the purpose.

SEC. 20. SK Funds. – The SK funds shall be governed by the following provisions:

x x x

(d) The budget cycle of the SK shall be synchronized with that of the barangay. As such, the sangguniang panlungsod or sangguniang bayan shall, within sixty (60) days upon receipt hereof, **review the annual budget and supplemental budget of the SK on their compliance with the immediately preceding provision and other existing laws, rules, and regulations. Noncompliance shall render said budgets inoperative either in whole or in part.** Failure on the part of the sanggunian to complete the review within the prescribed period shall render the said annual budget deemed approved.

Consistent with the afore-cited mandate, and considering that the attached documents to support the proposed Sangguniang Kabataan Annual Budget show that it has been properly examined and reviewed by the concerned City Accounting Office and City Budget Office in compliance with Republic Act No. 7160 and Revised Implementing Rules and Regulations (IRR) of Republic Act No. 10742, as amended, Honorable Rogelio M. Nolasco moved for the approval of Resolution **No. 007, Series of 2024.**

The motion was unanimously seconded by the majority of the Honorable Members of the 5<sup>th</sup> Sangguniang Panlungsod. The Annual Budget for Calendar Year 2024 of Sangguniang Kabataan of **Barangay LIGAS I**, Bacoor City was **APPROVED**, charge to the approved Annual General Fund of the Barangay for FY 2024.

**RECOMMENDATION:**

In view of the foregoing, the Honorable Members of the Committee hereby recommend **TO APPROVE** the Sangguniang Kabataan Annual Budget for CY2024 of **Barangay LIGAS I**, Bacoor City in the total amount of **ONE MILLION ONE HUNDRED EIGHTY-THREE THOUSAND SIX HUNDRED FIFTY-SEVEN PESOS AND TWENTY CENTAVOS**

Gentlemen/Mesdames,

This refers to the FY 2024 Annual Budget of the Sangguniang Kabataan of Barangay Ligas 1 involving an appropriation of P 1,183,657.20, passed and approved under Sangguniang Kabataan Resolution No.007 on Feb. 9, 2024 and received by this Office for review and evaluation.

Preliminary review of the submitted budget has been undertaken pursuant to Sec. 20 of RA 10742 and DBM/DILG/NYC Joint Memorandum Circular No. 1, s. 2019 dated January 23, 2019, the following are the findings and recommendations as basis for deliberation of the council:

- a. The total expenditure program does not exceed the estimates of income;
- b. All programs, projects and activities are based on the Annual Barangay Youth Investment Program (ABYIP);
- c. The amount provided for specific program, project and activity (PPA) is not higher than the amount provided in the ABYIP for the same PPA.
- d. Approved ABYIP is also submitted as an integral part of the SK annual budget;
- e. All other disbursement shall be subject to the usual accounting and auditing rules and regulations.



**RESOLUTION NO. 005 – SERIES OF 2024**

**A RESOLUTION APPROVING THE COMPREHENSIVE BARANGAY YOUTH DEVELOPMENT PLAN (CBYDP) 2024-2026 OF THE SANGGUNIANG KABATAAN (SK) OF BARANGAY LIGAS 1, ADOPTING AND INTEGRATING THE YOUTH DEVELOPMENT AND EMPOWERMENT PROGRAMS FOR BARANGAY LIGAS 1 YOUTH**

**WHEREAS**, the Republic Act 10742, or the Sangguniang Kabataan (SK) Reform Act of 2015, under Chapter II *The Katipunan ng Kabataan and the Sangguniang Kabataan* Sec. 8 *Powers and Functions of the Sangguniang Kabataan*, item (a) states that "The Sangguniang Kabataan shall, in consultation and concurrence of the Katipunan ng Kabataan, and within three (3) months from assumption to office, formulate a three (3)-year rolling plan which shall be known as the Comprehensive Barangay Youth Development, which shall serve as basis in the preparation of the Annual Barangay Youth Investment Program. This plan shall be aligned with the Philippine Youth Development Plan (PYDP) and other Local Youth Development Plans in every level, municipal, city and provincial as is relevant."

**WHEREAS**, the Republic Act 10742, or the Sangguniang Kabataan (SK) Reform Act of 2015, under Chapter II *The Katipunan ng Kabataan and the Sangguniang Kabataan* Sec. 8 *Powers and Functions of the Sangguniang Kabataan*, item (b) states that the Sangguniang Kabataan shall "Approve the annual budget which is the annual slice of the Annual Barangay Youth Investment Program before the start of the succeeding fiscal year, and, if the Sangguniang Kabataan funds allow, a supplemental budget."









**WHEREAS**, the Republic Act 10742, or the Sangguniang Kabataan (SK) Reform Act of 2015, under Chapter II *The Katipunan ng Kabataan and the Sangguniang Kabataan*, Section 8 *Powers and Functions of the Sangguniang Kabataan*, item (c) states that *"The Sangguniang Kabataan shall promulgate resolutions necessary to carry out the objectives of the youth in the barangay in accordance with the Comprehensive Barangay Youth Development Plan and the applicable provisions of this Act;"*

**WHEREAS**, the Implementing Rules and Regulations of Republic Act 10742 or the Sangguniang Kabataan (SK) Reform Act of 2015, under Rule II *The Katipunan ng Kabataan and the Sangguniang Kabataan*, Section 20 *SK Funds*, item (c) states that *"All SK funds shall be allocated in an annual budget, and if the funds allow, in a supplemental budget in accordance with the adopted ABYIP. Both the CBYDP and ABYIP shall give priority to programs, projects and activities that will promote and ensure equitable access to quality education, environmental protection, climate change adaptation, disaster risk reduction and resiliency, youth employment and livelihood, health, including health services and adolescent sexual and reproductive health, anti-drug abuse, gender sensitivity, sports development, and capability building which emphasizes leadership training."*

**WHEREAS**, the Comprehensive Barangay Youth Development Plan (CBYDP) 2024-2026, of the Sangguniang Kabataan (SK) of Barangay Ligas 1, shall promote and prioritize the welfare of the barangay youth through the youth development and empowerment-focused programs, projects, and activities (PPAs) integrated in it.

**WHEREAS**, the Department of Budget and Management (DBM) – Department of the Interior and Local Government (DILG) – National Youth Commission (NYC) Joint Memorandum Circular No. 1, s. 2019, or the Guidelines on the Appropriation, Release, Planning and Budgeting Process for the SK Funds signed January 23, 2019, under 3.0 *General Guidelines*, item 3.1 *Appropriation of the SK Fund by the Barangay*, item 3.3 *Planning and Budgeting Process for the SK Fund*, item 3.3.1 *Planning Process by the SK*, item 3.3.1.1 states that *"The SK, in consultation with the Katipunan ng Kabataan, shall formulate a 3-year rolling plan, which shall be known as Comprehensive Barangay Youth Development Plan (CBYDP). This plan shall be aligned with the Philippine Youth Development Plan and Local Youth Development Plans in provincial, city or municipal level."*

**WHEREAS**, the Department of Budget and Management (DBM) – Department of the Interior and Local Government (DILG) – National Youth Commission (NYC) Joint Memorandum Circular No. 1, s. 2019, or the Guidelines on the Appropriation, Release, Planning and Budgeting Process for the SK Funds signed January 23, 2019, under 3.0 *General Guidelines*, under item 3.1 *Appropriation of the SK Fund by the Barangay*, item 3.3 *Planning and Budgeting Process for the SK Fund*, under item 3.3.1 *Planning Process by the SK*, item 3.3.1.2 states that *"The CBYDP shall serve as the basis for the preparation of the Annual Barangay Youth Investment Program (ABYIP). The ABYIP shall contain the specific programs, projects, and activities with corresponding project costs, including the necessary fund flows to approximate the reasonable timing in the release of funds. It is understood that the ABYIP shall reflect the total resource requirement for the budget year."*






