Subject: **REQUEST FOR APPROVAL OF BARANGAY ORDINANCE FROM BARANGAY TALABA I: APPROPRIATION ORDINANCE NO. 2023-003 – ANNUAL GENERAL FUND OF BARANGAY TALABA I FOR CALENDAR YEAR 2024 IN THE AMOUNT PHP9,772,693.00 – PNOA-442-S-2024** dated April 15, 2024

Referred to this Committee during the 86th Regular Session is the above-subject matter for appropriate action and recommendation.

Consistent with the approved 2024 Annual Investment Program and DILG approved GAD Plan for Fiscal Year 2024, the Sangguniang Barangay of **TALABA I** enacted **Ordinance No. 2023-003** approving the 2024 Annual General Fund to cover the Personal Services (PS), Maintenance and Other Operating Expenses (MOOE), Capital Outlay (CO) and Special Purpose Allocation (SPA) which involved the total amount of **NINE MILLION SEVEN HUNDRED SEVENTY-TWO THOUSAND SIX HUNDRED NINETY-THREE PESOS (PHP9,772,693.00)**.

The attached documents to support the proposed Annual General Fund will readily show that it has been examined and reviewed by the concerned City Accounting Office and City Budget Office and that the same is in conformity with the provisions of Republic Act No. 7160 and existing budget circulars/issuances.

Upon the suspension of internal rules and referral to this Committee of said Barangay Ordinance No. 2023-003, Honorable Rogelio M. Nolasco moved for the approval of the same and the motion was unanimously seconded by the majority of the Honorable Members of the 5th Sangguniang Panlungsod. The Annual General Fund for Fiscal Year 2024 of Barangay **TALABA I**, Bacoor City for FY2024 was **APPROVED**, charge to its Receipt Program.

RECOMMENDATION:

In view of the foregoing, the Honorable Members of the Committee hereby recommend **TO APPROVE** the Appropriation Ordinance authorizing the Barangay Annual General Fund of Brgy. **TALABA I**, Bacoor City in the total amount of **NINE MILLION SEVEN HUNDRED SEVENTY-TWO THOUSAND SIX HUNDRED NINETY-THREE PESOS (PHP9,772,693.00)**, subject to the existing accounting and auditing rules and regulations.



Hon. Rogelio Nolasco: "Magandang Hapon po sa ating lahat, a committee hearing regarding "**PNOA-442-2024 – REQUEST FOR APPROVAL OF BARANGAY ORDINANCE FROM BARANGAY TALABA 1: APPROPRIATION ORDINANCE NO 2023-003: ANNUAL GENERAL FUND BUDGET OF BARANGAY TALABA 1 FOR CALENDAR YEAR 2024 IN THE AMOUNT OF PHP 9,772,693.00**", is court to order. Bago po ang lahat, we acknowledge the presence of City Councilor and Vice President of Liga ng mga Barangay, City Councilor Randy C. Francisco, ang aking mga kasama sa committee ay may hearing din today kaya po wala sila and for our record pwede pong magpakilala ang ating mga resource persons and what department?"

Hon. Rogelio M. Nolasco: "Thank you po, kasi po napansin ko ditto sa inyong budget sa 20% development fund fin form number 3a. So, yan po ang ating 20% Development Fund Php 1,544,538.60 ang naging question po rito ay bukod tanging ito sa lahat ng mga barangay na review ko po na walang identification kung saang location or area i relocate yung project kasi po kung



gagawa ng project kailangang naka indicate kung saang area yung project para malaman natin kung formerly Talaba 3, kasi kayo po ay merged barangay marami po kayong bagong court or street light kung saan iinstall so yun po ang kailangan naming malaman para po inyong ma identify sa Planning po."

Engr. Jose Henry Baluyot: "Sa amin po sa planning paki identify po sa street light ang specific location at itong solar panel at multipurpose hall syempre tatlo yan, paki identify na lang kung saan location yan at yung sa solar panel kung sa roof top ba yan? at iyung improvement of multipurpose hall kung ano yung iimprove nyo? Saka yung repair and repainting of multipurpose hall and barangay outpost. Bale ang hinahanap ni Chairman dito ay i identify yung specific location."

Ms. Meldy T. Rana: "Yes po, bale ang mangyayari po kasi merging to Talaba 1,3 and 7 so ang ilalagay po namin ay formerly Talaba 1."

Hon. Rogelio M. Nolasco: "Kailangang ilagay natin yung paglalagyan ng project kasi po kung i pa file nyo yan ng program of works sa engineering tatanungin din ng engineering kung saang lugar ito? At the same time kami rin ang mag iinspect kasi po lahat ng project ng City at ng Barangay ay dumadaan na po sa PMC Project Monitoring Committee so, may inspection kaming ginagawa once na nag submit kayo ng project kaya kailangan pong i identify. Mam Elvie may additional po kayo?"

Ms. Elvinia S. Guerrero: "May idadagdag lang po ako kung mayroon siyang street kailangang specific talaga yan. At kung i aadjust iyan kailangang bigyan uli kami ng bagong revised copy"

Hon. Rogelio M. Nolasco: "Kung irerevised nyo po, kailangang bigyan nyo po uli ng copy ang planning, Budget Office pati ang SP Secretariat at sa akin po. 1 copy each po. Atty.?"

Atty. Marius D. Sumira: "Regarding po dito nabigyan lang po kami ng copy from Mam Elvie, kung okey na po kay Mam Elvie okey na po sa amin. Kasi may revisions na po dito at recommendations."

Hon. Rogelio M. Nolasco: "Kaya nga, actually yun ang nakita kong lapses kasi merged barangay siya eh so kaya gusto naming Makita yung details of every project. Actually, nakikita ko sa ibang barangay nakalagay kung saang area. Para po maisa ayos natin kasi gagawa kayo ng program of work eh by Monday aapruban ko na ito by principle kaya po kailangang mai submit nyo agad yung revision ng Friday sa office andito naman si Sec. at Treasurer at papipirmahan nyo agad kay Kap. Mababago lang yung Form No. 3 kasi i specify nyo dito kung alin po yung area sa page 2 ng Social Development, Rehabilitation of Street Light kung saang area. Yung galing sa Planning? Yung AIP sa 20% Development Plan. Tama naman Mam Elvie yung MOOE?"



Ms. Elvinia S. Guerrero: "Kung minimal yung amount okay lang po sa MOOE pero kung malaki ang amount inilalagay po naming sa Capital Outlay. Kung bago dagdag siya sa asset ng barangay. Kahit sa atin ganoon din."

Hon. Rogelio M. Nolasco: "Isang insidente, na hold ko din yung Mambog 1 eh actually hindi ko rin tinanggap eh kasi ang nakalagay doon sa 20% ay construction of 3 Covered Courts as per Kapitan so, nakalagay doon ay construction of 3 covered courts amounting to PHP 1,200,000.00 kung ginawa nating construction may foundation yan so bago. Yung 1 milyon two hundred thousand ilang poste lang iyon. So, pinabago ko to rehabilitation and improvement. Ang sabi ko kay Mam Tinay from Capital Outlay i transfer to MOOE kasi maraming covered courts eh. Kaya sinasabi ko sa inyo hindi lang kayo pati nga yung Mambog 1 na hold ko ng twice para maitama natin."

Ms. Elvinia S. Guerrero: "At saka Konsi para malaman din nila na kahit tayo ay naka experience din sa province dahil ang hirap nilang mag review. Marami ding pinapa correct sa atin kaya na delay."

Hon. Rogelio M. Nolasco: "Maraming pinabago sa ating City Budget ang province kaya na delayed ang budget natin."

Ms. Elvinia S. Guerrero: "Na dating pwede, ngayon hindi na pwede."

Hon. Rogelio M. Nolasco: "Maganda nga ngayon Mam Elvie kasi from January to December eh, dati tayo quarterly lang so ngayon maalwan ang barangay sa pag implement ng project eh."

Hon. Rogelio M. Nolasco: "Kaya paki sabi na po kay Kapitan na by next year kailangan by October ay ready for submission na po ang budget para by January and February ay ready na para hindi tayo ma delay. Baka kasi ma question na tayo ng COA by late submission of budget. Ganoon din po sa mga SK."

Hon. Rogelio M. Nolasco: "Atty. Meron pa po kayong idadagdag?"

Atty. Marius D. Sumira: "No comments na po Konsi."

Hon. Rogelio M. Nolasco: "Any other comments?"

Ms. Elvinia S. Guerrero: "Kami po ay inaayos namin ang budget ng bawat barangay para maging pattern na rin dito sa City. Ini scrutinize kasi sa province dahil kasi sa SGLG, sa next SGLG dala na rin ang barangay para synchronize tayo."

Hon. Rogelio M. Nolasco: "Meron pa kayong question?"



Ms. Meldy T. Rana: "Yes po, ilalagay na po namin ang location ng bawat project at i reresubmit po namin after revision. Kagaya po ng Talaba 3 ni relocate po namin."

Hon. Rogelio M. Nolasco: "Specify nyo lang po yung location, kung repair or repaint same location kasi may existing na yan. Kung relocation from one site to another site. Kung bagong gagawin nyo? Construction yun."

Hon. Randy C. Francisco: "Kung yung nasa Talaba 3 na barangay outpost, Construction yun kasi yun yung pinagiba ni Mayor Lani dati."

Engr. Jose Henry Baluyot: "Ihiwalay nyo na lang po yung barangay outpost, magkano po ba ang budget nito Php 300,000.00? kung magkano yung allotment nyo dito ibukod nyo na lang po."

Ms. Elvinia S. Guerrero: "Kaso mo kung dati yang nasa MOOE at magkakaroon ng construction magiging capital outlay yan. Mayroong mababago doon sa mga barangay budget preparation forms."

Engr. Jose Henry Baluyot: "May file naman kayo sa computer, mababago nyo naman ito?"

Ms. Elvinia S. Guerrero: "Ganito na lang gawin nyo, magsa submit kayo ng bagong list? Dalhin nyo na lang sa office at iga guide namin kayo. Kung may mababago sa forms."

Hon. Rogelio M. Nolasco: "Ano ba yung multipurpose na i rerepair nyo? Formerly Talaba 1 or Talaba 3 and Talaba 7. Yung Solar panel paki specify nyo lahat para kapag nag inspection kami alam naming kung saan pupuntahan?"

Ms. Meldy T. Rana: "Construction po talaga yung sa barangay outpost kasi bago po iyon."

Engr. Jose Henry Baluyot: "So, ibabawas nyo na lang sa PHP 300,000.00?"

Ms. Meldy T. Rana: "Dito na rin po sa **20% Development Fund** hahatiin na lang po namin."

Gentlemen/Mesdames,

This refers to the FY 2024 Annual General Fund Budget of Barangay Talaba 1 involving an appropriation of P 9,772,693.00 passed and approved under Sangguniang Barangay Appropriation Ordinance No.2023-003 on December 18, 2023 and received by this Office for review and evaluation.

Preliminary review of the submitted budget has been undertaken pursuant to Republic Act. No. 7160 and other related issuances; the following are our findings and recommendation as basis for deliberation of the council:

1. The aggregate amount appropriated in the annual budget has not exceeded the estimates of income for the budget year.
2. Appropriation for development projects is set at P 1,544,538.60 which is equivalent to 20% of estimated NTA for the budget year. Utilization of the said fund is covered by DBM-DOF- DILG Joint Memorandum Circular No 1 dated Nov. 4, 2020.
3. Appropriation for Barangay Disaster Risk Reduction and Management Fund (BDRRMF) is set at 5% of the estimated revenue from regular sources. Disbursements thereof shall be in accordance with RA 10121 otherwise known as Philippine Disaster Risk Reduction and Management Act of 2010. The attached BDRRM Plan shows the distribution of the fund as per RA 10121.
4. SK fund was provided at 10% of the estimated revenue from regular sources
5. BCPC Fund was provided at 1% of NTA for the budget year as mandated by RA 9344 for the strengthening and implementation of the programs of the council.
6. 1% of the total budget was set aside for programs/projects/activities for Elderly/PWD as per DBM/DSWD Joint Circular No. 2003-01.
7. The rate of honoraria of barangay officials is within the rate of Salary Grade 14 and 10 of the salary
8. schedule implemented by the city for the chairman and members of the council/secretary/treasurer, respectively.
9. Approved GAD Plan and Budget is also submitted as an integral part of the barangay annual budget
10. Barangay Annual Investment Program (AIP) is hereto attached wherein projected programs are included in the Annual Budget.
11. Barangay Disaster Risk Reduction and Management (DRRM) Plan is hereto attached comprises of detailed plans and programs for the budget year.
12. All items in the barangay plantilla of personnel other than the mandatory positions prescribed under RA 7160 shall be in accordance with DBM LBC No. 137 (Index of Occupational Services, Position Titles and Salary Grades) dated July 13, 2021.
13. All other disbursement shall be subject to the usual accounting and auditing rules and regulations.

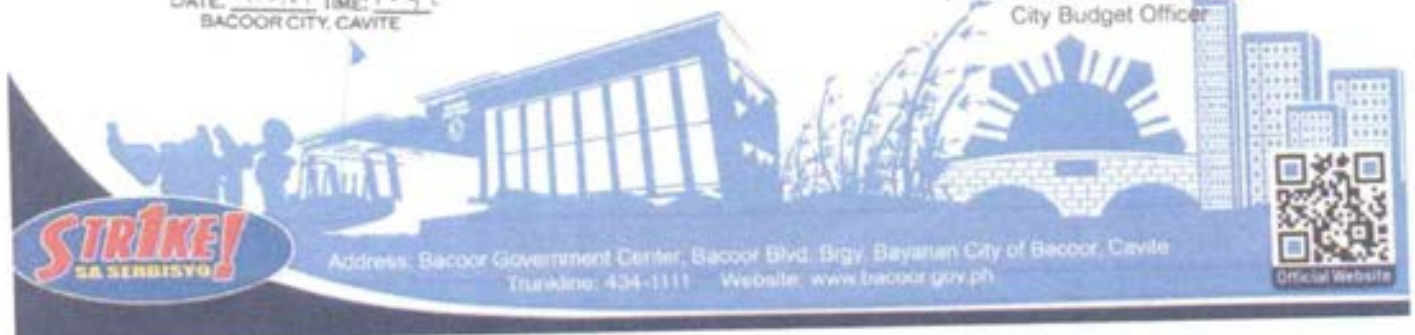

Section 4. General Provisions

1. All items of appropriation in this Ordinance shall be used only for the purpose for which they are appropriated.
2. In the use of savings, priority shall be given to the augmentation of existing but deficient amounts set aside for the payment of concouragement, personal benefits, leave credits.
Savings refer to portions or balances of any release appropriations in this Ordinance free from any obligation or encumbrance, still available after the satisfactory completion of the the unavoidable discontinuance or abandonment of the work, activity or purpose for which the appropriation is authorized, or arising from unpaid compensation and related costs pertaining to vacant positions and leaves of absence without pay.
3. The 40% Quick Response Fund (QRF) appropriated under the Barangay Disaster Risk Reduction and Management Fund (BDRRMF) shall be used as standby fund for relief and recovery program. The release and use of QRF shall be supported by a resolution of the Sangguniang Bayan declaring the barangay under a state of calamity or a Presidential declaration of a state of calamity.
4. The BDRRMF shall be used in accordance with R.A. No. 10121.
5. This Appropriation Ordinance will serve as the release document and all items of appropriation are comprehensively released, provided that if there is a shortfall in revenues, the Punong Barangay is authorized to issue a negative Allotment Release Order to reduce some of the amounts in the Appropriation Ordinance without need of further action from the Sangguniang Barangay.

Section 5. Separability Clause. If, for any reason, any Section or provision of this Appropriation Ordinance is disallowed in Budget Review or declared invalid by proper authorities, other Sections or provisions hereof that are not affected thereby shall continue to be full force and effect.

Section 6. Effectivity. The Provisions of this Appropriation Ordinance shall take effect on January 1, 2024
