Referred to this Committee on the 86th Regular Session is the above-subject matter for appropriate action and recommendation.

**Barangay NIOG** was the resultant barangay in the merging of former Barangays **NIOG 1, NIOG 2 and NIOG 3** pursuant to City Ordinance No. 275-2023 entitled "AN ORDINANCE MERGING VARIOUS BARANGAYS IN THE CITY OF BACOR, CAVITE TO ENSURE THEIR ECONOMIC GROWTH AND DEVELOPMENT, RENAMED THE MERGED BARANGAYS AND THE BARANGAYS AFFECTED BY SUCH MERGER, FIXING RESPECTIVE TERRITORIAL BOUNDARIES, AND APPROPRIATING FUNDS FOR THE HOLDING OF PLEBISCITE FOR THE APPROVAL HEREOF MANDATED BY LAW.". The Ordinance was duly ratified in a plebiscite held on July 29, 2023.

The barangay resolution (**RESOLUTION NO. 22, Series of 2024**) as approved by the Sangguniang Barangay of Barangay **NIOG** aimed to request the City Mayor to release the funds (TSTF) of the defunct barangays, receive the same by the Punong Barangay, and utilize/disburse said funds for the purpose intended and stated in the barangay resolution.

IN ACCORDANCE WITH THE PROPOSE BUDGET FOR DECEMBER 2023 OF BARANGAY NIOG 1, 2 AND 3 AS MERGED AND COMBINED.

**WHEREAS**, on July 29, 2023 a plebiscite was conducted pursuant to City Ordinance No. 275-2023 ratify the merging consolidation and remaining of various barangays in City of Bacoor, Cavite. And 90.44% of the voters consisted of yes votes.

**WHEREAS**, by virtue of successful ratification, Barangay Nio 1, Nio 2 and Nio 3 were merged as one barangay. The Barangay Nio is the surviving and an enlarged barangay local government or public corporation.

**WHEREAS**, considering the merging of 3 barangays with barangay Nio 1, Nio 2 and Nio 3 as the surviving and enlarged barangay, the appropriated funds accruing to the absorbed Barangay Nio will no longer be available for disbursement of their respective budget for the salaries of the Barangay Officials and employees, deliver of basic services, payment for the barangay utilities and most of all the benefits of the constituents of the surviving and enlarged Barangay Nio.

**WHEREAS**, the population, territory and other political details of surviving and enlarged Barangay Niog is the same as that of Barangay Niog 1, Niog 2 and Niog 3 as merged and combined.

**WHEREAS**, the Sangguniang Barangay of Barangay Niog 1, Niog 2 and Niog 3 are mindful of the above mentioned circumstances and the provision of law cited above, thereby enacted of Barangay Niog 1, Niog 2 and Niog 3 Ordinance No. 05 Series of 2023 effectivity date on November 15, 2023. This is to ensure that the incoming and surviving Barangay Niog will receive much needed funding for best serve the constituents of the same to include the constituents of Barangay Niog 1, Niog 2 and Niog 3 which ceased to exist on December 1, 2023. (Upon Barangay Niog pursuant to Sec. 14 R.A. 7160 absorbing Barangay Niog 1, Niog 2 and Niog 3.

**NOWTHEREFORE**, be it ordained by the Sangguniang Barangay of Barangay Niog, City of Bacoor, Cavite.

Authority of the Punong Barangay of merged and surviving merged Barangay Niog to request for the release and receiving of funds (TSTF) from the absorbed Barangay Niog 1, Niog 2 and Niog 3.

1. Authorizing the Punong Barangay of merged and surviving barangay Niog Hon. Alma R. Camarce to request from City Mayor Strike B. Revilla the release of funds (TSTF) of the absorbed barangay Niog 1, Niog 2 and Niog 3 stating the purpose and mode of disbursement and to receive the said funds (TSTF) requested.
2. Authorizing the Punong Barangay of merge and surviving Barangay Niog Hon. Alma R. Camarce, to submit to City Mayor Strike B. Revilla of Bacoor the proposed budget of merged and enlarged Barangay Niog for December 2023 in accordance with the proposed budget of Barangay Niog 1, Niog 2 and Niog 3.
