





Subject: REQUEST FOR APPROVAL OF SUPPLEMENTAL BUDGET OF BARANGAY MOLINO III: APPROPRIATION ORDINANCE NO. 2024-001; AN ORDINANCE AUTHORIZING SUPPLEMENTAL BUDGET NO. 1 SERIES OF 2024 INVOLVING THE AMOUNT OF TWO MILLIONONE HUNDRED THOUSAND PESOS(PHP2,100,000.00) – PNOA 455A-S-2024 dated April 15, 2024

Referred to this Committee on the 86th Regular Session is the above-subject matter for appropriate action and recommendation for approval of proposed Supplemental Budget No. 1 of Barangay MOLINO III, Bacoor City for FY2024 to be reappropriated in Capital Outlay (CO) for the purchase of motor vehicle.

The attached documents to support the proposed Supplemental Budget will readily show that it has been examined and reviewed by the concerned City Accounting Office and City Budget Office and that the same is in conformity with the provisions of Republic Act No. 7160 and existing budget circulars/issuances.

Upon the suspension of internal rules and referral to this Committee of said proposed supplemental budget, Honorable Rogelio M. Nolasco moved for the approval of the same and the motion was unanimously seconded by the majority of the Honorable Members of the 5th Sangguniang Panlungsod. The proposed Supplemental Budget No. 1 of Barangay MOLINO III, Baccor City for FY2024 in the total amount of TWO MILLION ONE HUNDRED THOUSAND PESOS (PHP2,100,000.00) was APPROVED charged to the Savings/General Fund of the Barangay.

In view of the foregoing, the Honorable Members of the Committee hereby recommend **TO APPROVE** the Appropriation Ordinance authorizing the Barangay Supplemental Budget No. 1 of Barangay **MOLINO III**, Bacoor City for FY2024 in the total amount of **TWO MILLION ONE HUNDRED THOUSAND PESOS (PHP2,100,000.00)**, subject to the existing accounting and auditing rules and regulations.




