Subject: **RESOLUTION NO. 008 – SERIES OF 2024: RESOLUTION APPROVING THE SANGGUNIANG KABATAAN (SK) OF BARANGAY MOLINO 1 ANNUAL BUDGET FOR CY 2024 AMOUNTING TO ONE MILLION NINE HUNDRED SIXTY-FIVE THOUSAND FOUR HUNDRED THIRTY PESOS AND NINETY CENTAVOS (PHP1,965,430.90) – PNOA 461-2024 dated April 22, 2024**

Referred to this Committee on the 87th Regular Session is the above-subject matter for appropriate action and recommendation.

Section 329 of Republic Act No. 7160 otherwise known as the "Local Government Code of 1991", provides that, and we quote:

"SECTION 329. Barangay Funds. – Unless otherwise provided in this Title, all the income of the barangay from whatever source shall accrue to its general fund and shall, at the option of the barangay concerned, be kept as trust fund in the custody of the city or municipal treasurer or be deposited in a bank, preferably government-owned, situated in or nearest to its area of jurisdiction. Such funds shall be disbursed in accordance with the provisions of this Title. Ten percent (10%) of the general fund of the barangay shall be set aside for the **sangguniang kabataan.**"

While the Sangguniang Kabataan is financially independent in its operations, disbursements, and encashment of its funds, income, and expenditures the Committee adheres to the provisions of the Revised Implementing Rules and Regulations (IRR) of Republic Act No. 10742, as amended, and hereunder quoted for ready reference:

"REVISED RULES AND REGULATIONS IMPLEMENTING REPUBLIC ACT (RA) NO. 10742, OTHERWISE KNOWN AS THE "SANGGUNIANG KABATAAN REFORM ACT OF 2015," AS AMENDED BY RA NO. 11768

(d) The appointed SK treasurers shall undergo mandatory bookkeeping training from, and **must be duly certified by the Technical Education and Skills Development Authority (TESDA)** before the assumption of office. Provided that, the mandatory bookkeeping training shall be in addition to the mandatory training under Section 31 of this Rules. Provided further, that only the certification from TESDA shall be considered for purposes of appointment as SK treasurer. Provided finally, that the appointed SK treasurers shall be prioritized in the allocation of appropriate TESDA scholarships in accordance with the guidelines to be issued by the TESDA for the purpose.

SEC. 20. SK Funds. – The SK funds shall be governed by the following provisions:

X X X

(d) The budget cycle of the SK shall be synchronized with that of the barangay. As such, the sangguniang panlungsod or sangguniang bayan shall, within sixty (60) days upon receipt hereof, **review the annual budget and supplemental budget of the SK on their compliance with the immediately preceding provision and other existing laws, rules, and regulations. Noncompliance shall render said budgets inoperative either in whole or in part.** Failure on the part of the sanggunian to complete the review within the prescribed period shall render the said annual budget deemed approved.

Consistent with the afore-cited mandate, and considering that the attached documents to support the proposed Sangguniang Kabataan Annual Budget show that it has been properly examined and reviewed by the concerned City Accounting Office and City Budget Office in compliance with Republic Act No. 7160 and Revised Implementing Rules and Regulations (IRR) of Republic Act No. 10742, as amended, Honorable Rogelio M. Nolasco moved for the approval of Resolution **No. 008, Series of 2024.**

The motion was unanimously seconded by the majority of the Honorable Members of the 5th Sangguniang Panlungsod. The Annual Budget for Calendar Year 2024 of Sangguniang Kabataan of **Barangay MOLINO I**, Bacoor City was **APPROVED**, charge to the approved Annual General Fund of the Barangay for FY 2024.

RECOMMENDATION:

In view of the foregoing, the Honorable Members of the Committee hereby recommend **TO APPROVE** the Sangguniang Kabataan Annual Budget for CY2024 of **Barangay MOLINO I**, Bacoor City in the total amount of **ONE MILLION NINE HUNDRED SIXTY-FIVE THOUSAND FOUR HUNDRED THIRTY PESOS AND NINETY CENTAVOS**

This refers to the FY 2024 Annual Budget of the Sangguniang Kabataan of Barangay Molino 1 involving an appropriation of P 1,965,430.90, passed and approved under Sangguniang Kabataan Resolution No.008 on Feb. 17, 2024 and received by this Office for review and evaluation.

Preliminary review of the submitted budget has been undertaken pursuant to Sec. 20 of RA 10742 and DBM/DILG/NYC Joint Memorandum Circular No. 1, s. 2019 dated January 23, 2019, the following are the findings and recommendations as basis for deliberation of the council:

- a. The total expenditure program does not exceed the estimates of income;
- b. All programs, projects and activities are based on the Annual Barangay Youth Investment Program (ABYIP);
- c. The amount provided for specific program, project and activity (PPA) is not higher than the amount provided in the ABYIP for the same PPA.
- d. Approved ABYIP is also submitted as an integral part of the SK annual budget;
- e. All other disbursement shall be subject to the usual accounting and auditing rules and regulations.

RESOLUTION NO. 005 – SERIES OF 2024

A RESOLUTION APPROVING THE APPROPRIATION OF 21.97% OF THE SANGGUNIANG KABATAAN (SK) FUND OF BARANGAY MOLINO I FOR THE HONORARIUM / PERSONAL SERVICES OF SANGGUNIANG KABATAAN (SK) COUNCIL

WHEREAS, the Republic Act No. 10742 or the Sangguniang Kabataan (SK) Reform Act of 2015, under Chapter II The Katipunan ng Kabataan and the Sangguniang Kabataan, Section 7 Creation and Election of the Sangguniang Kabataan, states that "There shall be in every barangay a Sangguniang Kabataan to be composed of a chairperson and seven (7) members who shall be elected by the registered voters of the Katipunan ng Kabataan. The Sangguniang Kabataan chairperson/shall, with the concurrence of the majority of the Sangguniang Kabataan members, appoint from among the members of the Katipunan ng Kabataan, a secretary and a treasurer."

WHEREAS, the Republic Act No. 10742 or the Sangguniang Kabataan (SK) Reform Act of 2015, under Chapter II The Katipunan ng Kabataan and the Sangguniang Kabataan, Section 8 Powers and Functions of the Sangguniang Kabataan, states that:

(a) in consultation and with the concurrence of the Katipunan ng Kabataan, and within three (3) months from assumption to office, formulate a three (3)-year rolling plan, which shall be known as the Comprehensive Barangay Youth Development Plan, which shall serve as basis in the preparation of the Annual Barangay Youth Investment Program. This plan shall be aligned with the Philippine Youth Development Plan (PYDP) and other Local Youth Development Plans in every level, municipal, city and provincial as is relevant;

(d) Initiate and implement, in coordination with any national government agency and/or any private or nongovernment institution, programs and projects designed to promote general welfare, development and empowerment of the youth;

(f) Create regular and special committees and such other bodies whose chairpersons and members of which shall come from among the members of the Sangguniang Kabataan or from among the members of the Katipunan ng Kabataan, as it may deem necessary to effectively carry out its programs and activities;

(j) Adopt and implement a policy on full public disclosure of all its transactions and documents involving public interest; and

WHEREAS, the Implementing Rules and Regulations (IRR) of Republic Act No. 10742, or the Sangguniang Kabataan (SK) Reform Act of 2015, under Rule II The Katipunan ng Kabataan and the Sangguniang Kabataan, Section 20 Sangguniang Kabataan Funds, item (b) states that "The SK shall have financial independence in its operations, disbursements and encashment of their funds, income and expenditures. As such, the SK funds shall be deposited in the name of the SK of the concerned barangay in a government-owned bank situated in or nearest to its area of jurisdiction with the SK chairperson and the SK treasurer as the official signatories;"

WHEREAS, the Section 4 of Republic Act No. 11768, amending Section 16 of the SK Reform Act of 2015 (RA No. 10742), item (6) states that "The Sangguniang Kabataan members, including the Sangguniang Kabataan treasurer and secretary, shall receive a monthly honorarium, chargeable against the Sangguniang Kabataan funds, in addition to any other compensation provided by this Act and shall be granted at the end of every regular monthly Sangguniang Kabataan meeting: Provided, that the monthly honorarium shall not exceed the monthly compensation received by the Sangguniang Kabataan chairperson: Provided, further, that not more that twenty-five percent (25%) of the Sangguniang Kabataan funds shall be allocated for personal services. The DBM shall issue the necessary guidelines implementing this provision."

WHEREAS, the Department of Budget and Management (DBM) Local Budget Circular No. 148, or the *Implementing Guidelines on the Grant of Honorarium to SK Officials Pursuant to Republic Act No. 11768, under 3.0 Policy Guidelines, 3.1 Grant of Honorarium to SK Officials, Charged Against the SK Funds*, states that:

3.1.3 The amount of the monthly honorarium of the SK Officials shall be subject to their attendance at SK meetings, deliberations, and official activities of the SK.

3.1.4 The monthly honorarium shall be pro-rated based on the actual work and/or attendance vis-a-vis the work and/or meeting schedule or performance standards as may be prescribed under the internal rules of the SK concerned.

3.1.5 The monthly honorarium to be received by SK Officials shall not exceed the rate equivalent to Salary Grade (SG) 9, Step 1 in the salary schedule implemented by the city or municipality/ where the barangay belongs. In no case shall the monthly honorarium exceed the actual monthly compensation received by the SK chairperson.

3.1.9 The grant of honorarium to SK Officials shall be included in the Comprehensive Barangay Youth Development Plan and Annual Barangay Youth Investment Program of the SK, and shall be subject to the SK planning and budgeting process pursuant to Department of Budget and Management (DBM)-Department of the Interior and Local Government (DILG)-National Youth Commission (NYC) Joint Memorandum Circular No. 1, s. 2019 dated January 23, 2019 and DILG Memorandum Circular No. 2019-151 dated September 10, 2019.

RESOLUTION NO. 008 – SERIES OF 2024

A RESOLUTION APPROVING THE SANGGUNIANG KABATAAN (SK) OF BARANGAY MOLINO I ANNUAL BUDGET FOR C.Y. 2024 AMOUNTING TO ONE MILLION NINE HUNDRED SIXTY-FIVE THOUSAND FOUR HUNDRED THIRTY PESOS AND 90/100 (Php 1,965,430.90)

WHEREAS, the Republic Act 10742, or the Sangguniang Kabataan (SK) Reform Act of 2015, under Chapter II Sec. 8 (b) states that the Sangguniang Kabataan shall "Approve the annual budget which is the annual slice of the Annual Barangay Youth Investment Program before the start of the succeeding fiscal year, and, if the Sangguniang Kabataan funds allow, a supplemental budget."

WHEREAS, the Republic Act 10742, or the Sangguniang Kabataan (SK) Reform Act of 2015, under Chapter II *The Katipunan ng Kabataan and the Sangguniang Kabataan*, Section 8 *Powers and Functions of the Sangguniang Kabataan*, item (c) states that "The Sangguniang Kabataan shall promulgate resolutions necessary to carry out the objectives of the youth in the barangay in accordance with the Comprehensive Barangay Youth Development Plan and the applicable provisions of this Act,"

WHEREAS, the Department of Budget and Management (DBM) – Department of the Interior and Local Government (DILG) – National Youth Commission (NYC) Joint Memorandum Circular (JMC) No.1, s. 2019, or the Guidelines on the Appropriation, Release, Planning and Budgeting Process for the SK Funds signed January 23, 2019, under 3.0 *General Guidelines*, item 3.1. *Appropriation of the SK Fund of the Barangay*, item 3.1.2 states that "For budget preparation purposes, the barangay treasurer shall inform, in writing, the SK chairperson and the SK treasurer on or before the 15th day of September of the estimated ten percent (10%) of the general fund of the barangay for the ensuing fiscal year, supported by a certification of income of the barangay from the city/municipal treasurer."

WHEREAS, Annual Barangay Youth Investment Program (ABYIP) 2024, with the approved Comprehensive Barangay Youth Development Plan (CBYDP) 2024-2026, of the Sangguniang Kabataan (SK) of Barangay Molino I **was finalized and approved dated February 17, 2024, by the virtue of SK Molino I, Resolution No. 007-2024**, as endorsed by the Katipunan ng Kabataan (KK) Members, and ratified by the SK Members.

WHEREAS, the Department of Budget and Management (DBM) – Department of the Interior and Local Government (DILG) – National Youth Commission (NYC) Joint Memorandum Circular No. 1, s. 2019, or the Guidelines on the Appropriation, Release, Planning and Budgeting Process for the SK Funds, under 3.3.4 *Budget Review by the Sangguniang Panlungsod or Sangguniang Bayan*, item 3.3.4 states that *"The sangguniang panlungsod or sangguniang bayan, as the case may be, shall within sixty (60) days upon receipt review the annual/supplemental budget of the SK in compliance with the priority programs, projects, and activities identified under Section 20 (c) of RA No. 10742, and with other existing laws, rules and regulations."*

WHEREAS, the SK Annual Budget for 2024, after the approval of the Annual Barangay Youth Investment Program (ABYIP) 2024 and the Comprehensive Barangay Youth Development Plan (CBYDP) 2024-2026, needs to be submitted and endorsed to the Sangguniang Panlungsod for its review and approval through the City Budget Office pursuant to the provisions of the DBM – DILG – NYC JMC No. 1, s.2019.




