Subject: *A RESOLUTION ENTERING A MEMORANDUM OF AGREEMENT WITH JENINA JUNKSHOP AS PARTNER IN THE SOLID WASTE DISPOSAL AND MANAGEMENT PROGRAM OF BARANGAY SALINAS I. (PNOA 470-2024 dated April 22, 2024).*

Members of the Sangguniang Panlungsod met in order to call the 88th Regular Session, at 10:00 AM, on 29 April, 2024. Presiding Officer, Vice Mayor Hon. Rowena Bautista-Mendiola, referred the above subject matter to Committee on Environment and Natural Resources. Barangay Council of Salinas and Jenina Junkshop agreed to enter into Memorandum of Agreement for the period of Two years from 2024 up to 2025 which may be terminated for any cause or renewed for another term, subject to a 30- days prior written notice.

FINDINGS:

Pursuant to Section 17(2)(vi) in relation to Section 17(4) of Republic Act No. 7160, otherwise known as the Local Government Code, the LGU-Bacoor, through its City Environment Service Department (CESD), has adopted a Solid Waste Disposal and Environmental Management System that ensure the provision of services and facilities related to general hygiene and sanitation.

The LGU-BACCOOR accordingly mandates the Association of Barangay Captain to coordinate and enforce the policies and guidelines in all Barangays that will support and enhance such solid waste disposal environmental management system.

The participation of the JENINA JUNKSHOP, a private organization that could beneficially is deemed essential and advisable to promote an efficient and extensive, yet cost-effective waste disposal. Address a cost effective disposal of recyclable wastes.

RECOMMENDATION:

In view of the foregoing, the Committee respectfully recommends that the proposed resolution of Barangay Salinas 1, Bacoor City, Cavite mentioned above be **APPROVED**.





MEMORANDUM OF AGREEMENT

KNOWN ALL MEN THESE PRESENTS:

This agreement made and entered into this 04 day of April, 2024 at the City of Bacoor, Cavite by and between:

The **BARANGAY SALINAS I, CITY OF BACOR**, a local government unit of the Republic of the Philippines, with principal place of business at Salinas I, City of Bacoor, Cavite, and represented herein by its Punong Barangay, **NECANOR D. ESPIRITU**, acting pursuant to the authority granted to him under Sangguniang Barangay Resolution No. 005 Series of 2024, herein after referred to as the "**BARANGAY LGU-BACOR**".

- and -

JENINA JUNKSHOP, a corporation duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with principal office address at **IBABA, BARANGAY SALINAS I, City of Bacoor, Cavite** represented by its owner/operator **ANGELINA O. CORNELIO**, duly authorized for the purpose and hereinafter referred to as the "**JUNKSHOP**".

WITNESSETH That:

WHEREAS, pursuant to Section 17(2)(vi) in relation to Section 17(4) of Republic Act No. 7160, otherwise known as the Local Government Code, the **LGU-BACOR**, through its City Environment and Natural Resources Office (CENRO), has adopted a Solid Waste Disposal and Environmental Management System that ensure the provision of services and facilities related to general hygiene and sanitation.

WHEREAS, the **LGU-BACOR** accordingly mandates the ABC to coordinate and enforce policies and guidelines in all Barangays that will support and enhance such solid waste disposal environmental management system;

WHEREAS, the involvement of the private sector is deemed essential and advisable to promote and efficient and extensive, yet cost-effective waste disposal and environmental management system;

WHEREAS, the **JUNKSHOP**, a private organization composed of Junkshop owners situated in Bacoor City, Cavite, could effectively and beneficially address the disposal of recyclable wastes in all Barangays within the City;

WHEREAS, the **CITY ENVIRONMENT AND NATURAL RESOURCES OFFICE** and the **BARANGAY** both recognize that indeed, the partnership with the **JUNKSHOPS** will mutually beneficial and advantageous.

NOW THEREFORE, for and in consideration of the foregoing premises and of the terms and conditions hereinafter set forth, the parties hereby agree as follows:

I. OBLIGATIONS OF THE PARTIES

I.1 THE LGU-BACOR

- a. Mandate its CENRO to monitor the compliance of the BARANGAY and the JUNKSHOPS with the conditions of this Agreement;

I.2 THE BARANGAY

- a. Designate pick-up points for the recyclable wastes and appoint collectors who shall be provided with proper uniforms and identification cards, subject to the availability of funds. The said collectors shall monitor the weighing of the recyclable wastes at the premises of the member-junkshop chosen by each Barangay and shall maintain records for the data.

I.3 THE JUNKSHOPS

- a. Enjoin its member junkshops to obtain and maintain in full force and effect during the entire term of this Agreement at their sole cost and expense, all required license and permits as well as to abide by all existing laws and ordinances.
- b. Allow the inspection of the premises of its members by the CENRO, to ensure the maintenance of hygiene and sanitation as well as compliance with all environmental protection laws.

2. SEPARABILITY CLAUSE

The invalidity of one or more phrases, sentences, clauses or sections contained in this agreement shall not affect the validity of the remaining portion of the Agreement, so long as the material purposes of this Agreement can be determined and effectuated.

3. EFFECTIVITY

This Agreement shall be effective for a period of two (2) years from 2024 up to year 2025 its execution, which may or pre-terminated for any cause or renewed for another term, subject to a thirty (30) days prior written notice to the Parties.






