Subject: RESOLUTION NO. 07, SERIES OF 2024: A RESOLUTION TO CLOSE THE ACCOUNT WITH AN ACCOUNT NAME TALABA V WITH AN ACCOUNT NUMBER 001422101973 IN THE LANDBANK OF THE PHILIPPINES IMUS BRANCH - PNOA 473-2024 dated April 22, 2024

Referred to this Committee on the 87<sup>th</sup> Regular Session is the above-subject matter for appropriate action and recommendation.

Barangay Talaba 5 was abolished in the merging of former barangays Talaba 4, Talaba 5 and Talaba 6 pursuant to City Ordinance No. 275-2023 entitled "AN ORDINANCE MERGING VARIOUS BARANGAYS IN THE CITY OF BACDOR, CAVITE TO ENSURE THEIR ECONOMIC GROWTH AND DEVELOPMENT, RENAMED THE MERGED BARANGAYS AND THE BARANGAYS AFFECTED BY SUCH MERGER, FIXING RESPECTIVE TERRITORIAL BOUNDARIES, AND APPROPRIATING FUNDS FOR THE HOLDING OF PLEBISCITE FOR THE APPROVAL HEREOF MANDATED BY LAW". The Ordinance was duly ratified in a plebiscite held on July 29, 2023.

### FINDINGS:

The approved RESOLUTION No. 07 Series of 2024 of the Sangguniang Barangay of new Barangay Talaba 3 to close the depository account of former Barangay **Talaba 5** with the Land Bank of the Philippines (LBP) Imus Branch is reasonable considering that said Barangay Talaba 5 had ceased to exist.

### RECOMMENDATION:

In view of the foregoing, the Honorable Members of the Committee hereby recommend **TO APPROVE** Barangay Resolution No. 07, Series of 2024 of Barangay Talaba 3, Bacoor City, subject to the guidelines issued by the Department of Budget and Management (DBM) and Bureau of the Treasury (BTr) in the closing of barangay/LGU bank accounts.



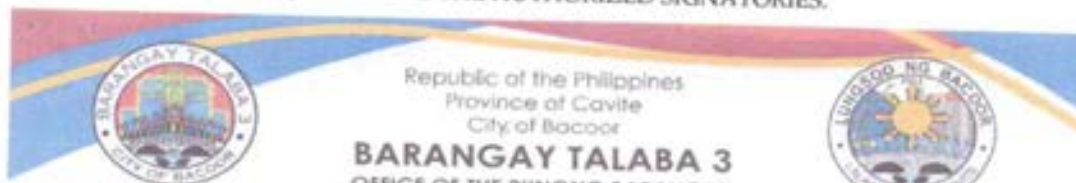

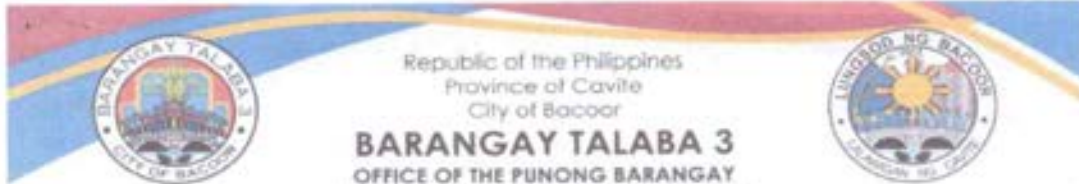
