Referred to this Committee during the 88<sup>th</sup> Regular Session is the above-subject matter for appropriate action and recommendation.

Consistent with the approved 2024 Annual Investment Program and DILG approved GAD Plan for Fiscal Year 2024, the Sangguniang Barangay of **ANIBAN I** enacted **Ordinance No. 2023-003** approving the 2024 Annual General Fund to cover the Personal Services (PS), Maintenance and Other Operating Expenses (MOOE), Capital Outlay (CO) and Special Purpose Allocation (SPA) which involved the total amount of **NINE MILLION EIGHT HUNDRED TWENTY-THREE THOUSAND FOUR HUNDRED SIXTY PESOS (PHP9,823,460.00)**.

The attached documents to support the proposed Annual General Fund will readily show that it has been examined and reviewed by the concerned City Accounting Office and City Budget Office and that the same is in conformity with the provisions of Republic Act No. 7160 and existing budget circulars/issuances.

Upon the suspension of internal rules and referral to this Committee of said Barangay **Ordinance No. 16-2023** Honorable Rogelio M. Nolasco moved for the approval of the same and the motion was unanimously seconded by the majority of the Honorable Members of the 5<sup>th</sup> Sangguniang Panlungsod. The Annual General Fund for Fiscal Year 2024 of **Barangay ANIBAN I**, Bacoor City was **APPROVED**, charge to its Receipt Program.

Gentlemen/Mesdames,


This refers to the FY 2024 Annual General Fund Budget of Barangay Aniban 1 involving an appropriation of P 9,823,460.00 passed and approved under Sangguniang Barangay Appropriation Ordinance No. 16-2023 on December 22, 2023 and received by this Office for review and evaluation.

Preliminary review of the submitted budget has been undertaken pursuant to Republic Act. No. 7160 and other related issuances; the following are our findings and recommendation as basis for deliberation of the council:

1. The aggregate amount appropriated in the annual budget has not exceeded the estimates of income for the budget year.
2. Appropriation for development projects is set at P 1,644,692.00 which is equivalent to 20% of estimated NTA for the budget year. Utilization of the said fund is covered by DBM-DOF- DILG Joint Memorandum Circular No.1 dated Nov. 4, 2020.
3. Appropriation for Barangay Disaster Risk Reduction and Management Fund (BDRRMF) is set at 5% of the estimated revenue from regular sources. Disbursements thereof shall be in accordance with RA 10121 otherwise known as Philippine Disaster Risk Reduction and Management Act of 2010. The attached BDRRM Plan shows the distribution of the fund as per RA 10121.
4. SK fund was provided at 10% of the estimated revenue from regular sources.
5. BCPC Fund was provided at 1% of NTA for the budget year as mandated by RA 9344 for the strengthening and implementation of the programs of the council.
6. 1% of the total budget was set aside for programs/projects/activities for Elderly/PWD as per DBM/DSWD Joint Circular No. 2003-01.
7. The rate of honoraria of barangay officials is within the rate of Salary Grade 14 and 10 of the salary schedule implemented by the city for the chairman and members of the council/secretary/treasurer, respectively.
8. Approved GAD Plan and Budget is also submitted as an integral part of the barangay annual budget.
9. Barangay Annual Investment Program (AIP) is hereto attached wherein projected programs are included in the Annual Budget.
10. Barangay Disaster Risk Reduction and Management (DRRM) Plan is hereto attached comprises of detailed plans and programs for the budget year.
11. All items in the barangay plantilla of personnel other than the mandatory positions prescribed under RA 7160 shall be in accordance with DBM LBC No. 137 (Index of Occupational Services, Position Titles and Salary Grades) dated July 13, 2021.
12. All other disbursement shall be subject to the usual accounting and auditing rules and regulations.

**"AN ORDINANCE AUTHORIZING THE ANNUAL BUDGET OF BARANGAY ANIBAN - 1 FOR FISCAL YEAR 2024 IN THE TOTAL AMOUNT OF NINE MILLION EIGHT HUNDRED TWENTY THREE THOUSAND FOUR HUNDRED SIXTY PESOS (PHP9,823,460.00) AND APPROPRIATING THE NECESSARY FUNDS FOR THE PURPOSE OF VARIOUS EXPENDITURES ON THE OPERATION OF THE BARANGAY GOVERNMENT OF ANIBAN 1, CITY OF BACOOR, CAVITE."**

**Section 4. General Provisions.** The sources of funds particularly the Tax Revenue and Operating and Miscellaneous Income that will be collected by the Barangay Treasury will finance and prioritize the herein appropriations for the delivery of basic services and implementation of development projects, programs and activities:

- a. Income from operating and miscellaneous fees shall be collected at maximum collection efficiency
- b. Priority in the use of income shall be for budgetary requirements as mandated by the local code
  - 20% of NTA for development projects shall be consistent with the development agenda of the government to Section 305 of the Local Government Code
  - 5% for Unforeseen Events, disbursement of appropriation for Calamity shall be used for expenditures provided in Republic Act No. 9155
    - 30% (of 5%) Quick Response Fund is appropriated under the BDRMF standby fund for relief and recovery program. BDRMF shall be used in accordance with R.A. 10121
  - 10% for Sangguniang Kabataan (SK) shall conform to the implementation of youth development programs.
- c. Strict compliance to the 55% Personal Services limitation shall be observed
- d. The appropriations for Gender and Development shall be based on the estimated cost of functions, programs, projects and activities pursuant to Joint Memorandum Circular No. 2001-01 of the DILG, DBM and NCRFW. Cities/Barangays shall prepare a GAD Plan addressing the gender issues of the locality following Sections 16 and 17 of the Code
- e. Priority in the use of savings shall be for basic services, augmentation of development projects and other mandatory expenses under the Local Code
- f. All procurement shall follow strictly the provisions of Republic Act No. 9154.

**Section 5. Separability Clause.** If, for any reason, any Section or provision of this Appropriation Ordinance is disallowed in Budget Review or declared invalid by proper authorities, other Sections or provisions hereof that are not affected thereby shall continue to be in full force and effect.

**Section 6. Effectivity.** This barangay appropriation ordinance shall take effect immediately on January 1, 2024.


