Referred to the Joint Committee on the 89<sup>th</sup> Regular Session is the above-subject matter for appropriate action and recommendation.

During the Joint Committee hearing the representatives of Barangay P.F. Espiritu 4, Bacoor City expressly manifested the withdrawal of the proposed barangay resolution for the reason that the number of affected families failed to qualify with the required 50% affected individuals based on the total barangay population or on the 30% affected livelihood to cause the declaration of the state of calamity.

**RECOMMENDATION:**

In view of the foregoing, the Honorable Members of the Joint Committee hereby recommend **TO ARCHIVE** Barangay Resolution **No. 12, Series of 2024** of Barangay P.F. Espiritu 4, Bacoor City declaring a state of calamity in the area to facilitate the release of the amount of FIFTY-FIVE THOUSAND PESOS (PHP55,000.00) to be sourced out from Barangay Risk Reduction and Management Fund of the said Barangay.


