WHEREAS, the Barangay Zapote 1, City of Bacoor, Cavite is mandated to perform various functions and duties for the welfare and development of its constituents;

WHEREAS, due to the fact that the location of the aforementioned projects has not been changed and already submitted to City Budget Office and Sangguniang Panglunsod;

WHEREAS, the Sangguniang Barangay Council of Barangay Zapote 1, wants to prioritize the rehabilitation of the streetlights in Purok Zapote 2, due to the very high consumption of electricity bills that the barangay is shouldering due to the households suspected of being attached to the line of barangay streetlights; the Rehabilitation of Drainage Canal prioritize the streets at purok Zapote 2, due to public demand of the constituents in the streets of Aquamarine, Pearl Garnet, Diamond and Emerald.

WHEREAS, the changing of location of the Annual Development Plan thru this resolution requesting the Sangguniang Panglungsod to approve the following matters, to wit;

- (a) Rehabilitation of Streetlights to Barangay Proper to Pasilyo 23 ( Yellow bell St.) to the streets of Purok Zapote 2, Ruby St., Diamond St., Peridot St., and Garnet St.;
- (b) Rehabitation of Drainage Canal to Barangay Proper to Pasilyo 23 (Yellow bell St.) to the streets of Aquamarine, Pearl, Garnet, Diamond and Emerald.
