Subject: ORDINANCE NO. 02-2024 SERIES OF 2024: AN ORDINANCE PROHIBITING ENTRIES OF MOTORCYCLE RIDERS WEARING FULL FACED, HALF FACED HELMET AND MASK IN BARANGAY SALINAS 2. *(PNOA 501-2024 dated May 13, 2024)*

Upon review of the documents submitted by Barangay Salinas 2 regarding the above-mentioned subject matter, the committee found out that the proposed ordinance contradicts Republic Act 10054 (The "Motorcycle Helmet Act of 2009"), Section 3 of which explicitly provides the "Mandatory Use of Helmets" and the existing ordinance enacted by the Sangguniang Panlungsod entitled: "AN ORDINANCE AUTHORIZING HOMEOWNERS ASSOCIATIONS AND BARANGAY OFFICIALS TO REQUIRE MOTORCYCLE RIDERS AND BACK RIDERS TO TEMPORARILY REMOVE THEIR HELMETS BEFORE ENTERING A GATED COMMUNITY OR BARANGAY CHECKPOINT FOR THE MAINTENANCE OF PUBLIC SAFETY AND PROVIDING PENALTIES FOR VOLATIONS HEREOF."

RECOMMENDATION:

In view thereof, the committee respectfully recommends for the **DISAPPROVAL** of the above-mentioned proposed ordinance of Barangay Salinas 2.

Gutierrez the said proposed ordinance contradicts the existing law on motorcycle riders to wear protective helmet at all times as well as the existing ordinance enacted by the Sangguniang Panlungsod re: Motorcycle Rider Identification Ordinance of the City of Bacoor. Since the internal rules were already suspended, the motion met no objection and was unanimously seconded by the Council and was deemed approved by the Chair.

AN ORDINANCE PROHIBITING ENTRIES OF MOTORCYCLE RIDERS WEARING FULL FACED, HALF FACED HELMET AND MASK IN BARANGAY SALINAS 2.

WHEREAS, The Barangay is committed to promote the safety, peace and order of its territorial jurisdiction.

WHEREAS, all motorcycle drivers and their passengers shall be required under this ordinance to remove their helmets and/or anything that will conceal their identities when they are entering in Camella Homes Subdivision within the area of responsibility of Barangay Salinas 2.

WHEREAS, Section 16 of R.A. 7160 of Local Government code States:

SECTION 16. GENERAL WELFARE- every Local Government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate and effective governance and those which are essential to the promotion of the General Welfare.

WHEREAS, in support for the program of the Local Government unit and the Philippine National Police in crime prevention and minimizes criminal act in our area of responsibilities.

WHEREAS, Barangay Salinas 2 is with in Camella Homes, a private Subdivision and enclosed with a perimeter fence within the boundaries of Barangays Salinas 1, Real and Habay 2.

WHEREAS, it has only 2 Entry as points located in Zone 4 former Barangay Salinas 4 and Mercury Street between the boundary of Salinas 1 and Salinas 2.


NOW THEREFORE, the said ordinance was unanimously approved by the Sangguniang Barangay.


